Whereas, on the 18th day of February, 2013 a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from **EXPRESS WASH INC**, the owner of said land for the costs and expenses thereof and thereunder.






