GENERAL WARRANTY DEED
With Right of Survivorship

COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Two Hundred Sixty-Nine Thousand Dollars and NO/100 (\$269,000.00)** to the undersigned grantors, in hand paid by the grantees herein, the receipt whereof is acknowledged, we, **Jeremy T. Giadrosich and Lindsay N. Giadrosich, husband and wife**, (herein referred to as grantors), grant, sell, bargain and convey unto, **Tina L. Jernigan and Thomas W. Jernigan** (herein referred to as grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:


Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.
