KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of November, 2017, Hope Deflora-Filyaw and Joseph Filyaw, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Mortgage Lenders of America, L.L.C., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20171113000408970, said mortgage having subsequently been transferred and assigned to Flagstar Bank, FSB, by instrument recorded in Instrument No. 20181119000407420, in the aforesaid Probate Office ("Transferee"); and

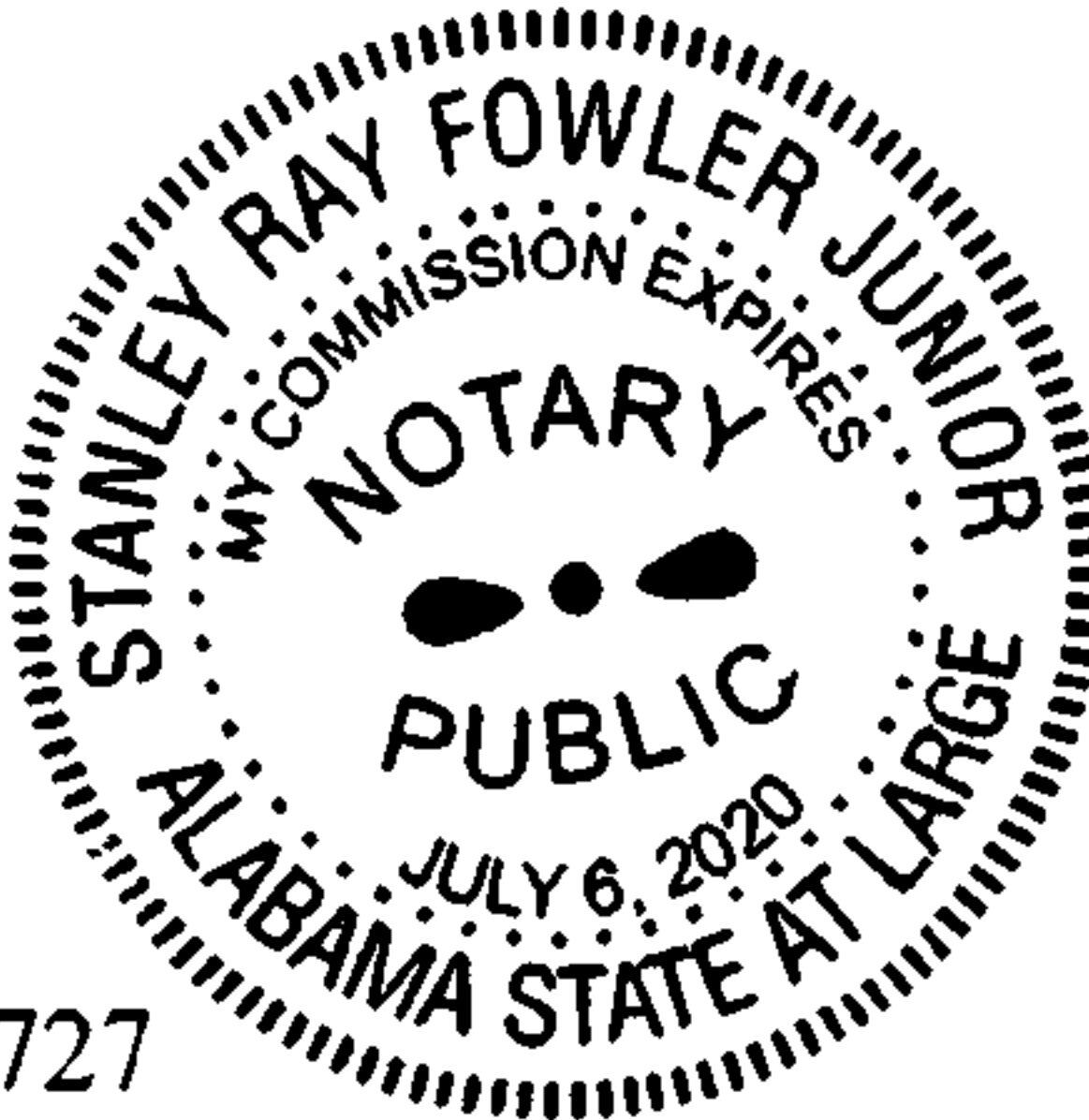

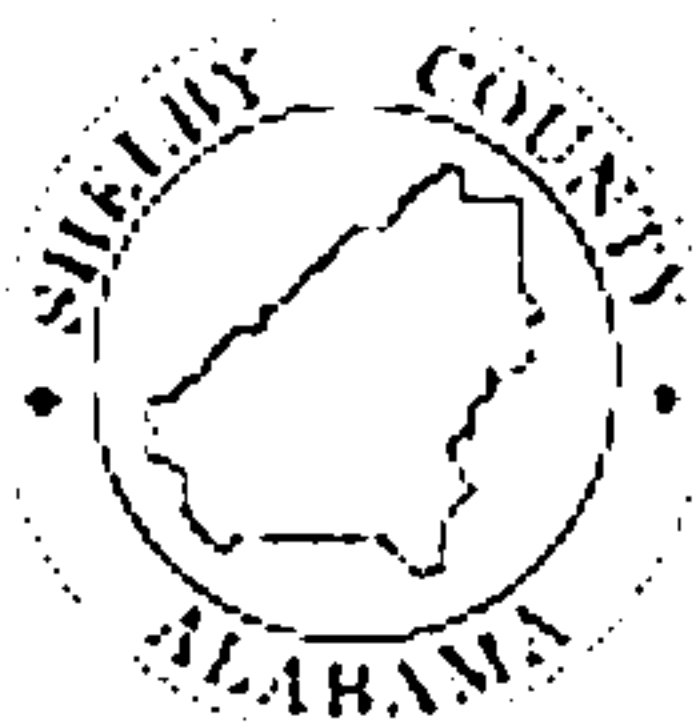
