STATUTORY WARRANTY DEED WITH RIGHT OF SURVIVORSHIP

That in consideration of Three Hundred Eight Thousand Eight Hundred Five Dollars and No Cents (\$308,805.00) to the undersigned Grantor, Newcastle Construction, Inc., an Alabama Corporation (herein referred to as Grantor) in hand paid by the Grantees, herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Michael Alan Hensley and Lita Bowers Hensley (herein referred to as Grantees), as joint tenants, with right of survivorship the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 23A, according to the Survey of Hillsboro, Phase 1 Amended, as recorded in Map Book 39, Page 140 A, B, and C, in the Probate Office of Shelby County, Alabama.

Subject to: All easements, restrictions and rights of way of record.


\$303,210.00 of the above mentioned purchase price was paid for from a mortgage loan which was closed simultaneously herewith.

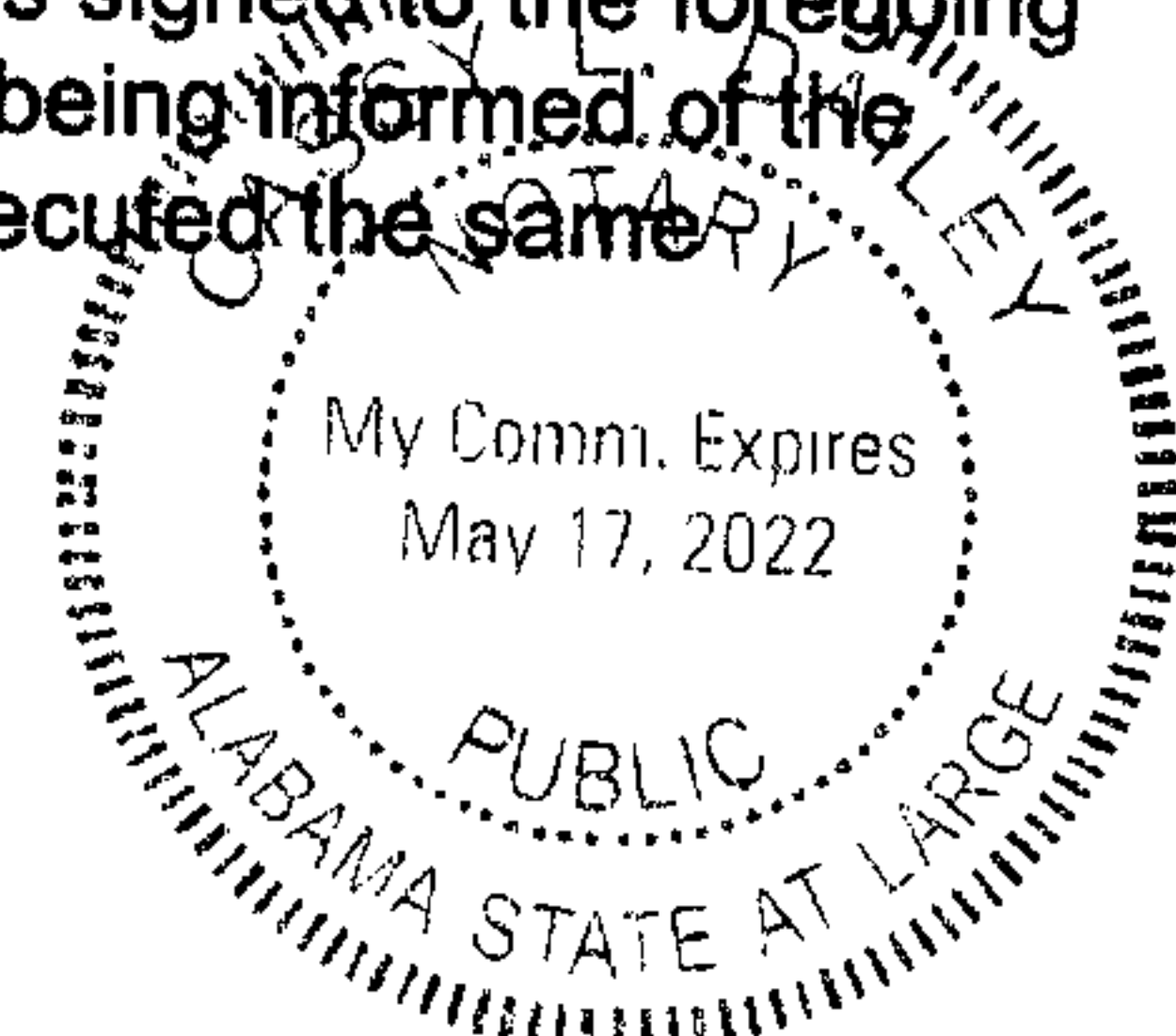
