KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TWO HUNDRED FIFTY THOUSAND AND NO/100 DOLLARS (\$250,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, **BRANDON QUICK and SARAH QUICK, husband and wife** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **EMILY E. HOLSOMBACK and NATHANIEL B. HOLSOMBACK** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 419-A, according to the Survey of Shelby Forest Estates Resurvey No. 1, as recorded in Map Book 27, Page 64, in the Probate Office of Shelby County, Alabama.

Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, reservations, mineral/mining rights, and declarations of record, if any.

\$250,000.00 of the above-recited purchase price is being paid with a purchase money mortgage being recorded simultaneously herewith.



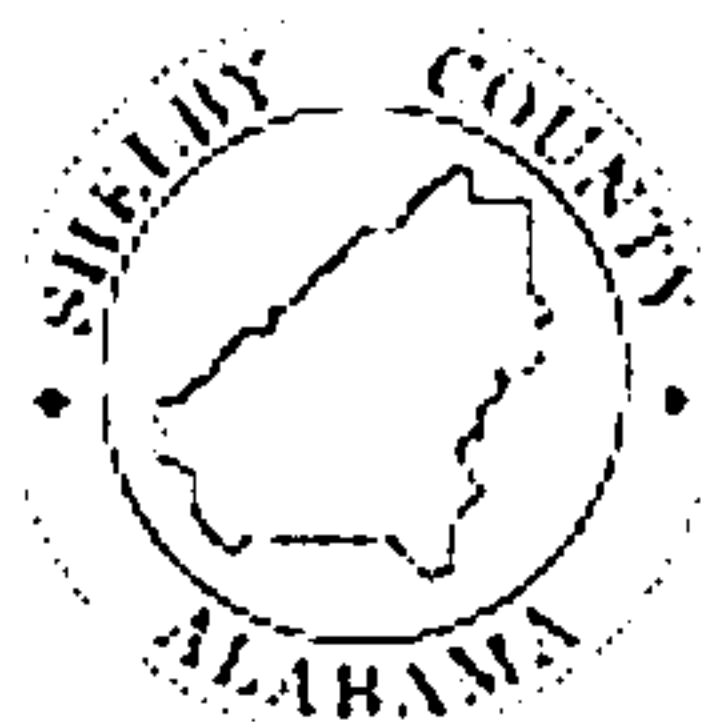
