Situated in Shelby County.



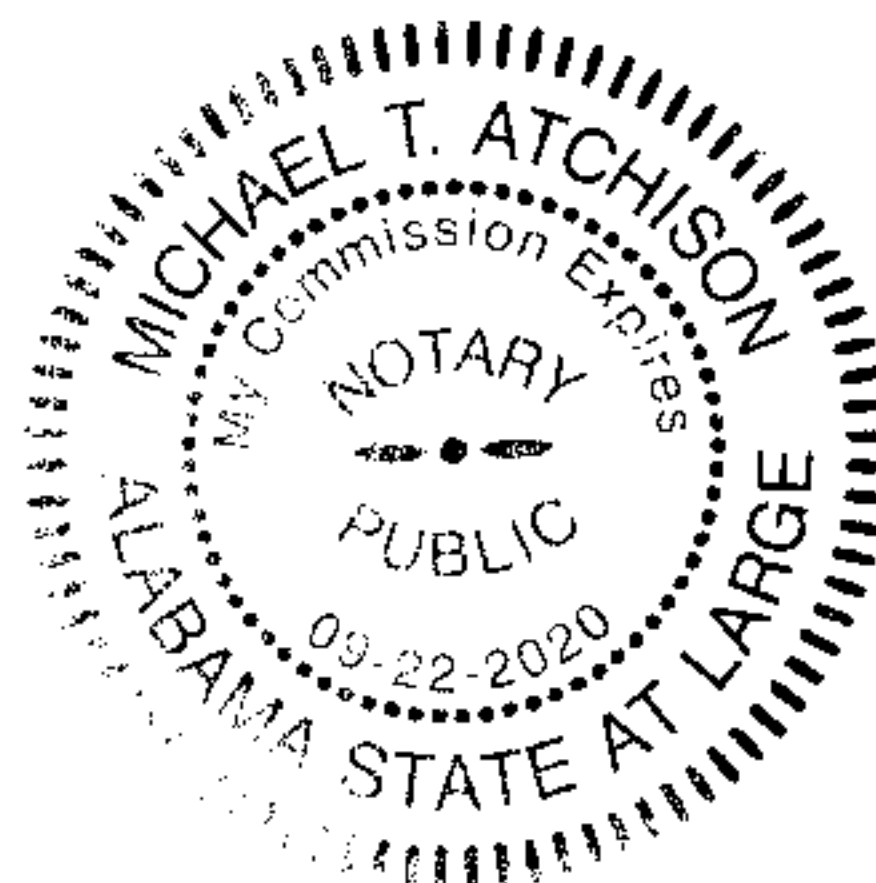
