(NOW ALL MEN BY THESE PRESENTS, That <u>Greystone Way, LLC, a Florida limited liability company</u>, as grantor(s), (the "Grantor", whether one or more) for and consideration of One and No/100 Dollar (\$1.00) and other good and valuable consideration paid to Grantor in hand by Alabama Power Company, an Alabama corporation, the receipt and sufficiency of which are hereby acknowledged, does hereby grant to Alabama Power Company, its successors and assigns (the Company"), the easements, rights and privileges below.

Nerhead and/or Underground. The right from time to time to construct, install, operate and maintain, upon, over, under and across the Property described below, ill poles, towers, wires, conduits, fiber optics, cables, communication lines, transclosures, transformers, anchors, guy wires and other facilities useful or necessary a connection therewith (collectively, "Facilities"), for the overhead and/or underground transmission and distribution of electric power and communications, along ne route shown on the Company's drawing attached hereto as Exhibit "A" and made a part hereof. The Company is granted the right to clear, and keep clear, all rees, undergrowth and other obstructions on a strip of land extending five (5) feet from each side of said underground Facilities, and to clear, and keep clear, all rees, undergrowth and other obstructions on a strip of land extending fifteen (15) feet from each side of the centerline of said overhead Facilities and the right in the ature to install intermediate poles and facilities on said strip. Further, with respect to overhead Facilities, the Company is also granted the right to trim and cut, and eep trimmed and cut, all dead, weak, leaning or dangerous trees or limbs outside of the thirty (30) foot strip that, in the sole opinion of the Company, may now or ereafter endanger, interfere with, or fall upon any of said overhead Facilities.

his instrument does not grant the exclusive use of the Property and the Grantor shall have the right to utilize said Property in any way that does not interfere with ne exercise by the Company of the rights herein granted. he easements, rights and privileges granted hereby shall apply to, and the word "Property" as used in this instrument shall mean, the portion of the following escribed real property situated in Shelby County, Alabama described on Exhibit "A" attached hereto (the "Property"): a parcel of land located in the North ½ of the W ¼ and in the SE ¼ of the NW ¼ of Section 6, Township 21 South, Range 4 West, being more particularly described in that certain instrument recorded in strument #20181102000389870, in the office of the Judge of Probate of said County.

hould Grantor transfer ownership of the Property without complying with the preceding provision, Grantor shall indemnify and hold Company harmless from any ss, damage, fees, expenses, or judgments incurred as a result thereof.

the event it becomes necessary or desirable for the Company from time to time to move any of the Facilities in connection with the construction or improvement any public road or highway in proximity to the Facilities, Grantor hereby grants to the Company the right to relocate the Facilities and, as to such relocated acilities, to exercise the rights granted above; provided, however, the Company shall not relocate said Facilities on the Property at a distance greater than ten feet 0') outside the boundary of the right of way of any such public road or highway as established or re-established from time to time. This grant and agreement shall binding upon and shall inure to the benefit of Grantor, the Company and each of their respective heirs, personal representatives, successors and assigns and the ords "Company" and "Grantor" as used in this instrument shall be deemed to include the heirs, personal representatives, successors and assigns of such parties.
