Know All Men by These Presents: That in consideration of **Four Hundred Four Thousand Two Hundred Twenty-Six and no/100 Dollars (\$404,226.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **AKU RAINIO and VUOKKO RAINIO** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

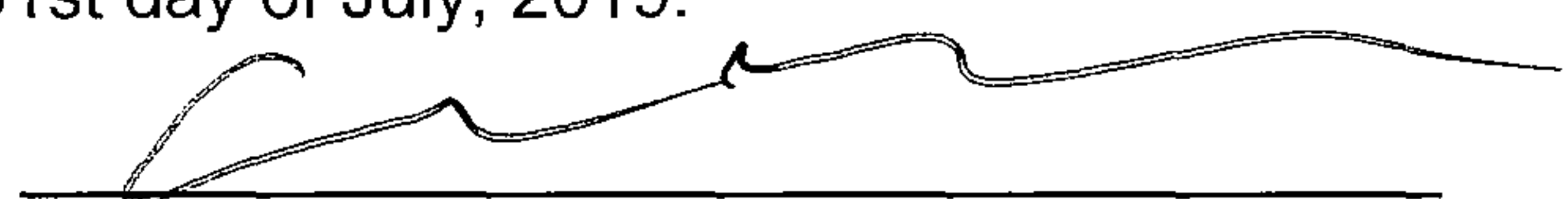
