County of Shelby

That in consideration of the sum of **Seventy Five Thousand Dollars and No Cents (\$75,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Cecil D. Loftin**, a married man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Daniel A. Guess** and wife Alex Galvez (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lots 3 & 4, Block 92, according to the survey of Dunstan's Map of the Town of Calera, Alabama, as recorded in Deed Book 302, Page 269, in the Probate Office of Shelby County, Alabama.

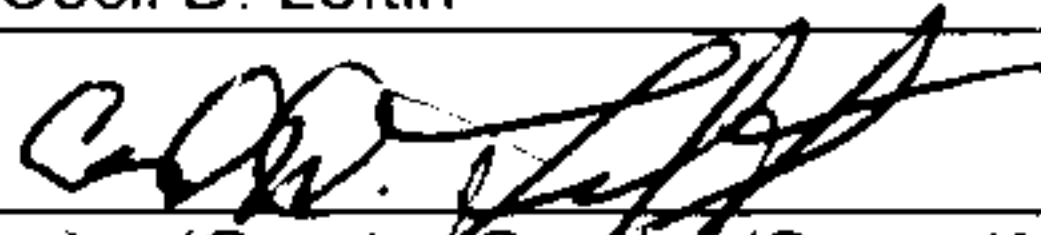
