KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on to-wit, April 12, 2005, Jayson D. Bray, a single man and Marketta Stanley, a single woman, ("Mortgagors"), executed a certain mortgage ("Mortgagee") to Mortgage Electronic Registration Systems, Inc. solely as a nominee for Southeastern Mortgage of Alabama, LLC said Mortgage being recorded April 22, 2005 in Instrument Number 20050422000192290 in the Office of the Judge of Probate of Shelby County, Alabama; having been assigned to Green Tree Servicing LLC by instrument recorded in Instrument No. 20140703000201490, in the Office of the Judge of Probate of Shelby County, Alabama.

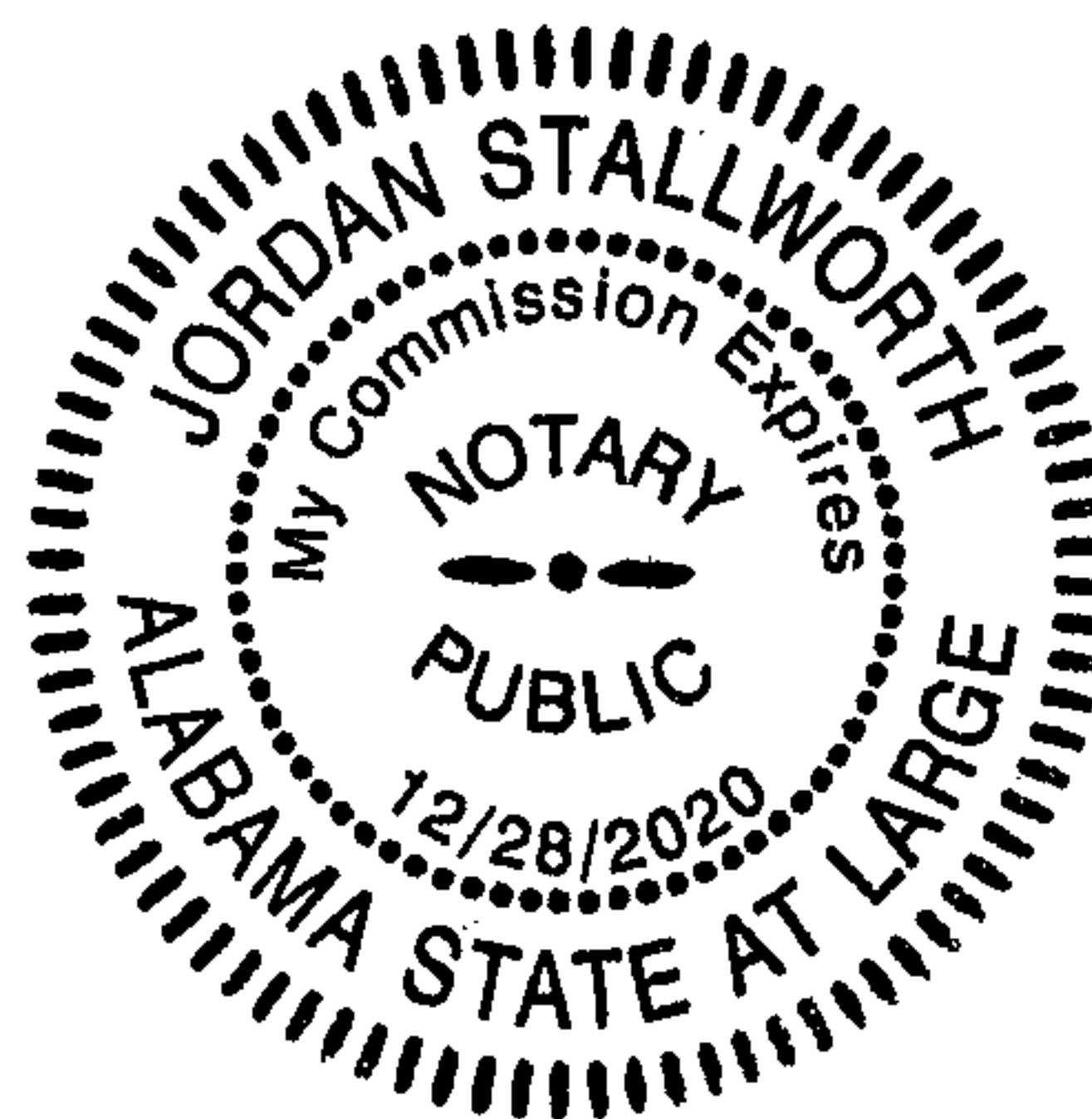
