WHEREAS, pursuant to a writ of execution issued out of the State Department of Revenue, State of Alabama, Montgomery, Alabama, under the authority of Section 40-2-11(16), Code of Alabama 1975, the Sheriff of Shelby County, Alabama, did on September 22, 2014 by virtue of his authority as Sheriff of said County offer for sale and did sell to the State of Alabama the following described property owned by taxpayer HK DE LA TORRE AKA DELA TORRE, KEAT G and CAROLYN B DE LA TORRE, to wit:

Lot 488, according to the Survey of Caldwell Crossings Fourth Sector, Phase Two, as recorded in Map Book 36, Page 149, in the Probate Office of Shelby County, Alabama.

WHEREAS, the Sheriff of Shelby County, issued a Sheriff's Deed to the State of Alabama which was subsequently recorded in the Probate Office of Shelby County, Instrument# 20141204000381530; and

WHEREAS, HK DE LA TORRE AKA DELA TORRE, KEAT G and CAROLYN B DE LA TORRE tendered payment of the taxes due the State Department of Revenue together with interest, penalties and costs in order to redeem the above described property from the State Department of Revenue; and

WHEREAS, it has been certified to the Governor by Vernon Barnett, Commissioner of Revenue of the State of Alabama, that all requirements of law with respect to the redemption of said property have been complied with and that a sale has been obtained and negotiated;


NOW THEREFORE, I, Kay Ivey, as Governor of the State of Alabama, pursuant to the provisions of Section 35-4-385, Code of Alabama 1975, for and in consideration of the taxes due the State Department of Revenue together with interest, penalties, and costs paid to the State of Alabama and receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey to HK DE LA TORRE AKA DELA TORRE, KEAT G and CAROLYN B DE LA TORRE, the taxpayer's heirs and assigns, all interests in and to the said land described herein which shall or may have accrued to the State

of Alabama at said execution sale pursuant to the writ set out in the said deed of the Sheriff of Shelby County, Alabama to the State of Alabama;

TO HAVE AND TO HOLD, the above described property, unto the said HK DE LA TORRE AKA DELA TORRE, KEAT G and CAROLYN B DE LA TORRE, the taxpayer's heirs and assigns forever, without warranty or covenant of any kind on the part of the State of Alabama, either expressed or implied.
