FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of September, 2007, Mary L. Davidson, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Hamilton Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070925000449750, said mortgage having subsequently been transferred and assigned to CSMC 2018-RPL3 Trust, by instrument recorded in Instrument number 20190610000203160, in the aforesaid Probate Office ("Transferee"); and


WHEREAS, on September 17, 2019, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and CSMC 2018-RPL3 Trust did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, E21 LLC was the highest bidder and best bidder in the amount of One Hundred Forty-Four Thousand Six Hundred Nine And 00/100 Dollars (\$144,609.00) on the indebtedness secured by said mortgage, the said CSMC 2018-RPL3 Trust, by and through Sirote & Permutt, P.C., as attorney for said Transferee, does hereby remise, release, quit claim and convey unto E21 LLC all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:


