2. The Company is being formed as a limited liability company.


8. The Company shall be managed by the Managing Members as set out in the Company Agreement.

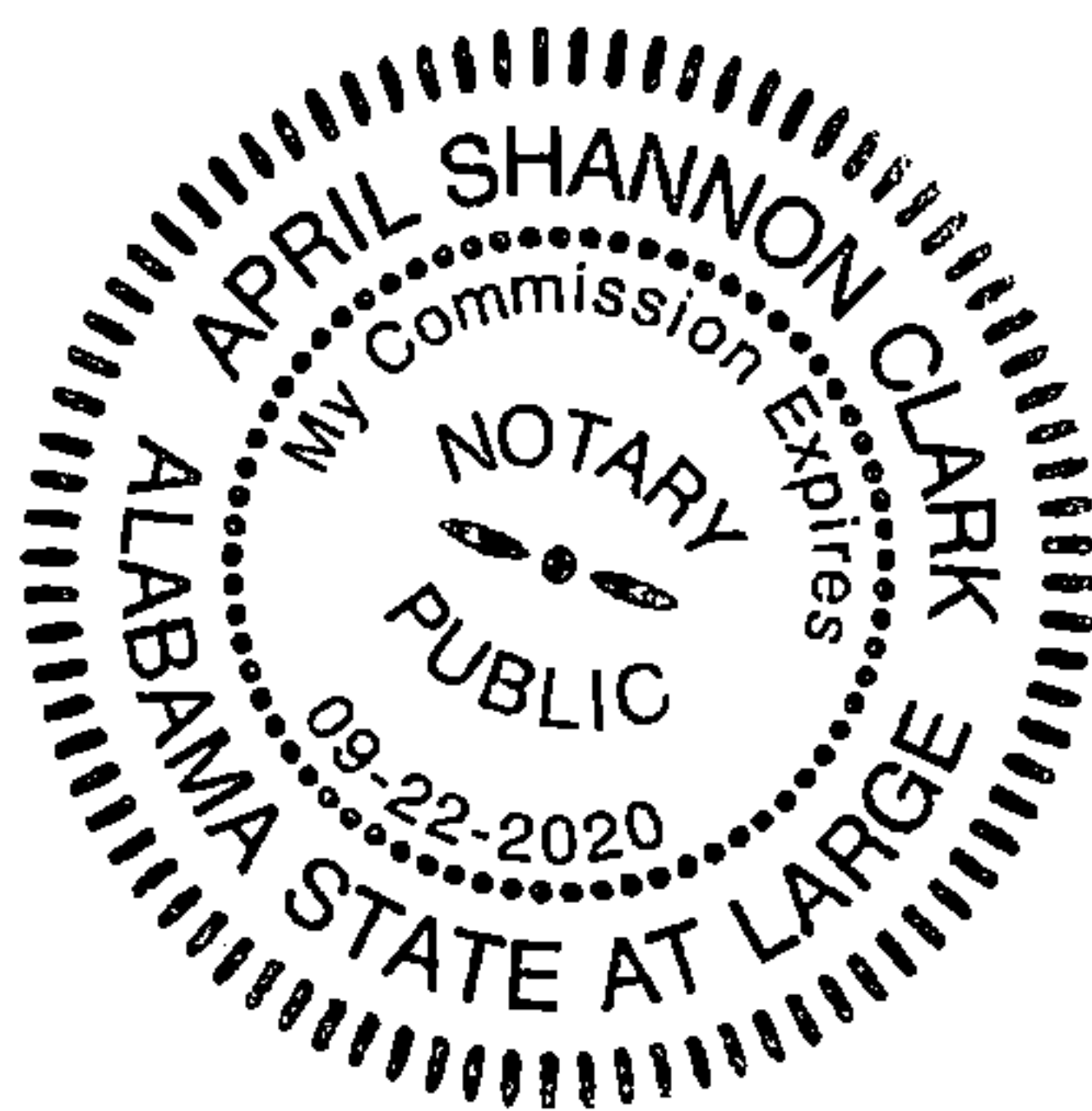
