Subject to:


1. General and special taxes or assessments for the year 2019 and subsequent years not yet due and payable.

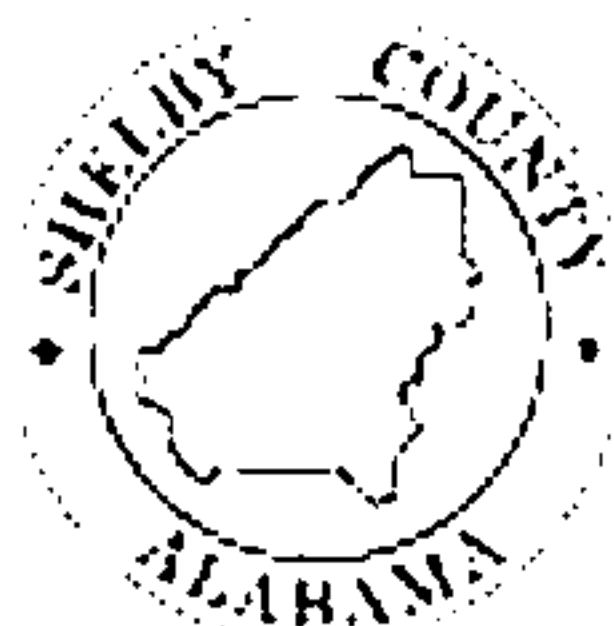
