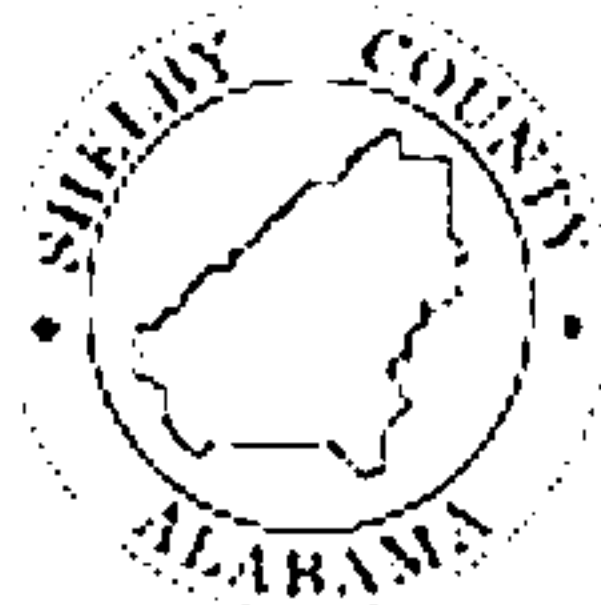
That in consideration of Four Hundred Twenty-One Thousand Six Hundred
