That in consideration of **Five Hundred Fifteen Thousand and 00/100 Dollars (\$515,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Anthony Plaia and Annette Plaia

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 4, according to the Survey of Hunter's Addition to Riverchase, as recorded in Map Book 8, Page 147, in the Probate Office of Shelby County, Alabama



\$484,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

- Subject to: (1) 2020 ad valorem taxes not yet due and payable;
- (2) all mineral and mining rights not owned by the Grantors; and
- (3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

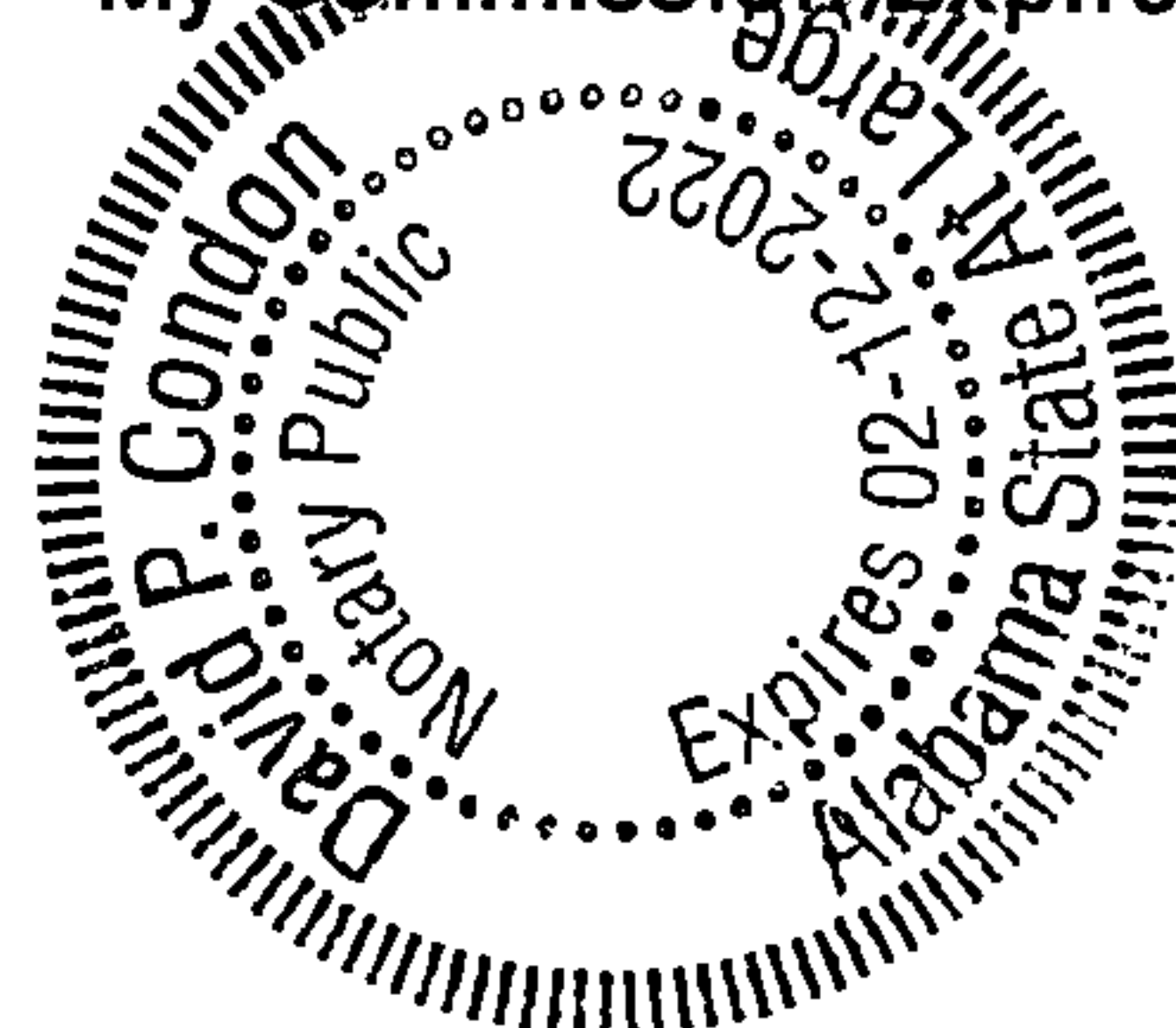
