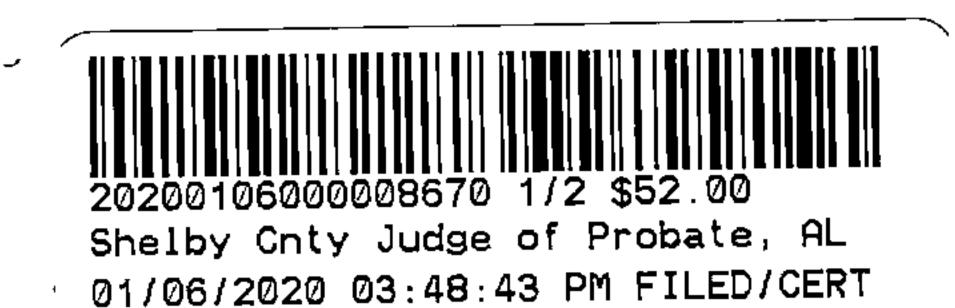
WARRANTY DEED

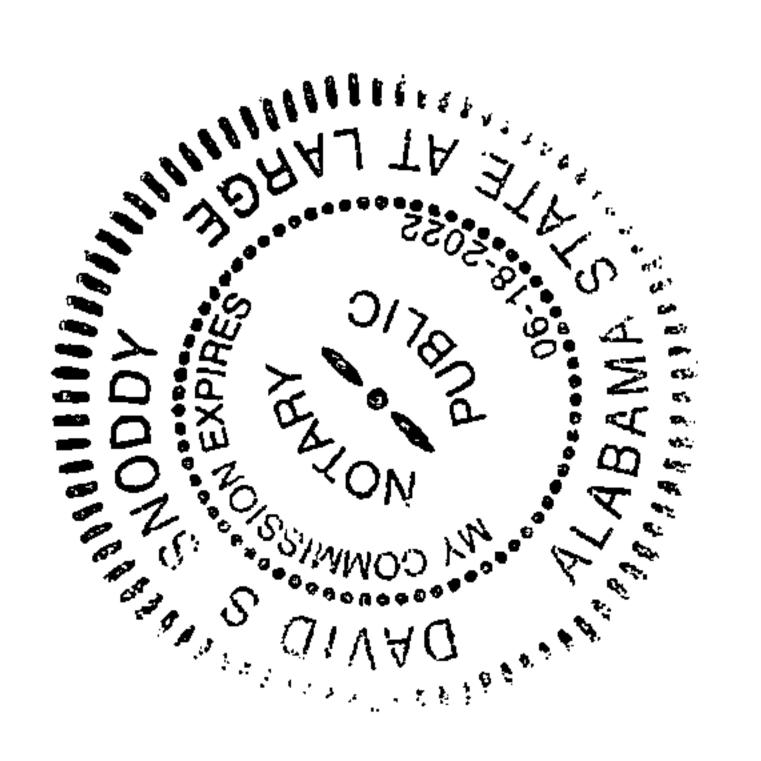
