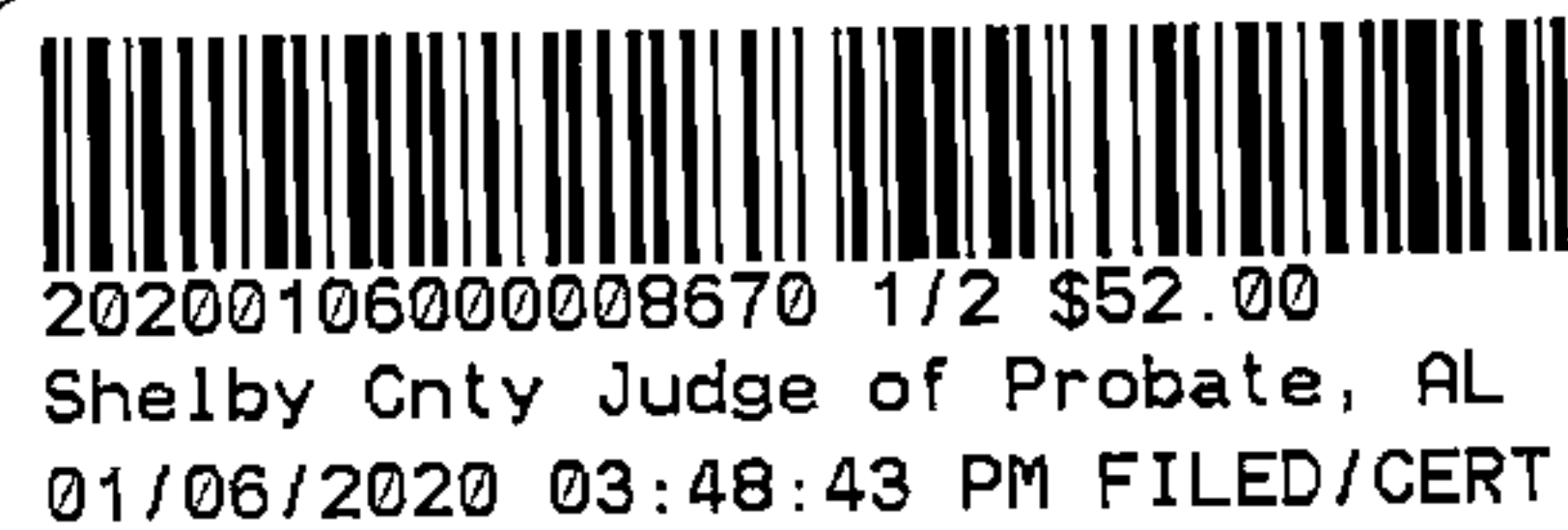


WARRANTY DEED

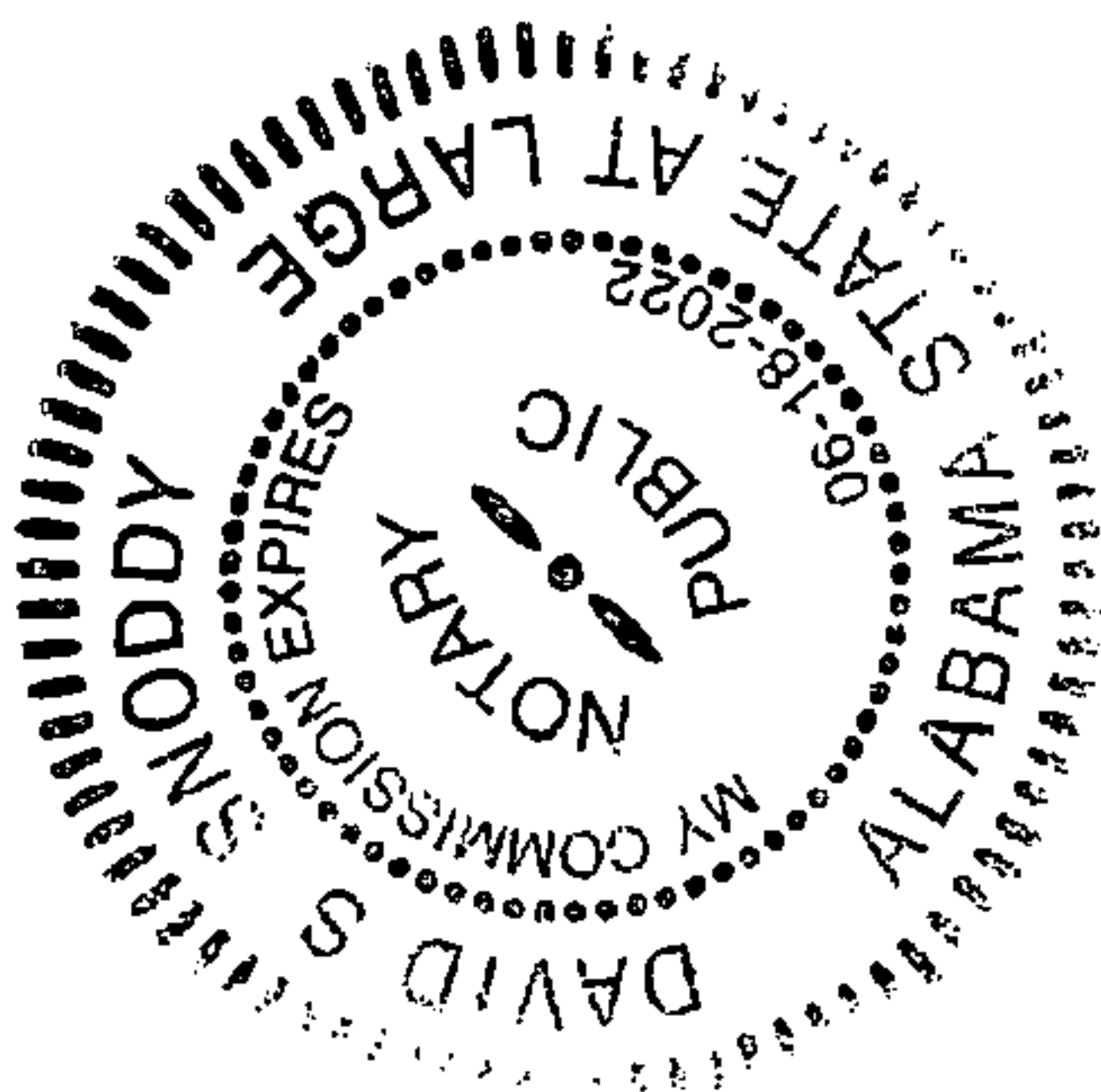
