TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, desiring to form a limited liability company under the laws of the State of Alabama, do hereby adopt the following Articles of Organization:

## ARTICLE I NAME

The name of the limited liability company shall be Stella Rose Boutique, LLC (the "Company").

### ARTICLE II PERIOD OF DURATION

The term for which the Company is to exist as a limited liability company shall commence on the date these Articles of Organization are filed, and shall continue in perpetual existence or until the Company shall be dissolved (a) upon the written consent of all members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act, as amended from time to time (the "Act").

## ARTICLE III PURPOSE

The Company is formed to transact any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Act, including, but not limited to manufacturing, assembly, services, contracting, or any other lawful business such as operating any business such as a restaurant, social membership society club, or such other commercial or industrial business of any nature, acquiring, owning, operating, managing, mortgaging, encumbering, selling, exchanging, otherwise disposing of and/or dealing with investments for the production of income and profit and the operation, management, leasing and developing of property owned by the Company, both real and personal and to engage in any and all activities related or incidental to the business of the Company.

## ARTICLE IV LOCATION OF REGISTERED OFFICE AND NAME OF REGISTERED AGENT

The initial registered office of the Company shall be at 439 Alta Vista Drive, Chelsea, Alabama, and the name of the initial registered agent at such address shall be Lindsay Smith. The Principal place of business of the company shall be at 439 Alta Vista Drive, Chelsea, Alabama 35043.

## ARTICLE X LIABILITIES OF MEMBERS AND MANAGERS


