Map Book 38, Page 137, in the Probate Office of Shelby County, Alabama.

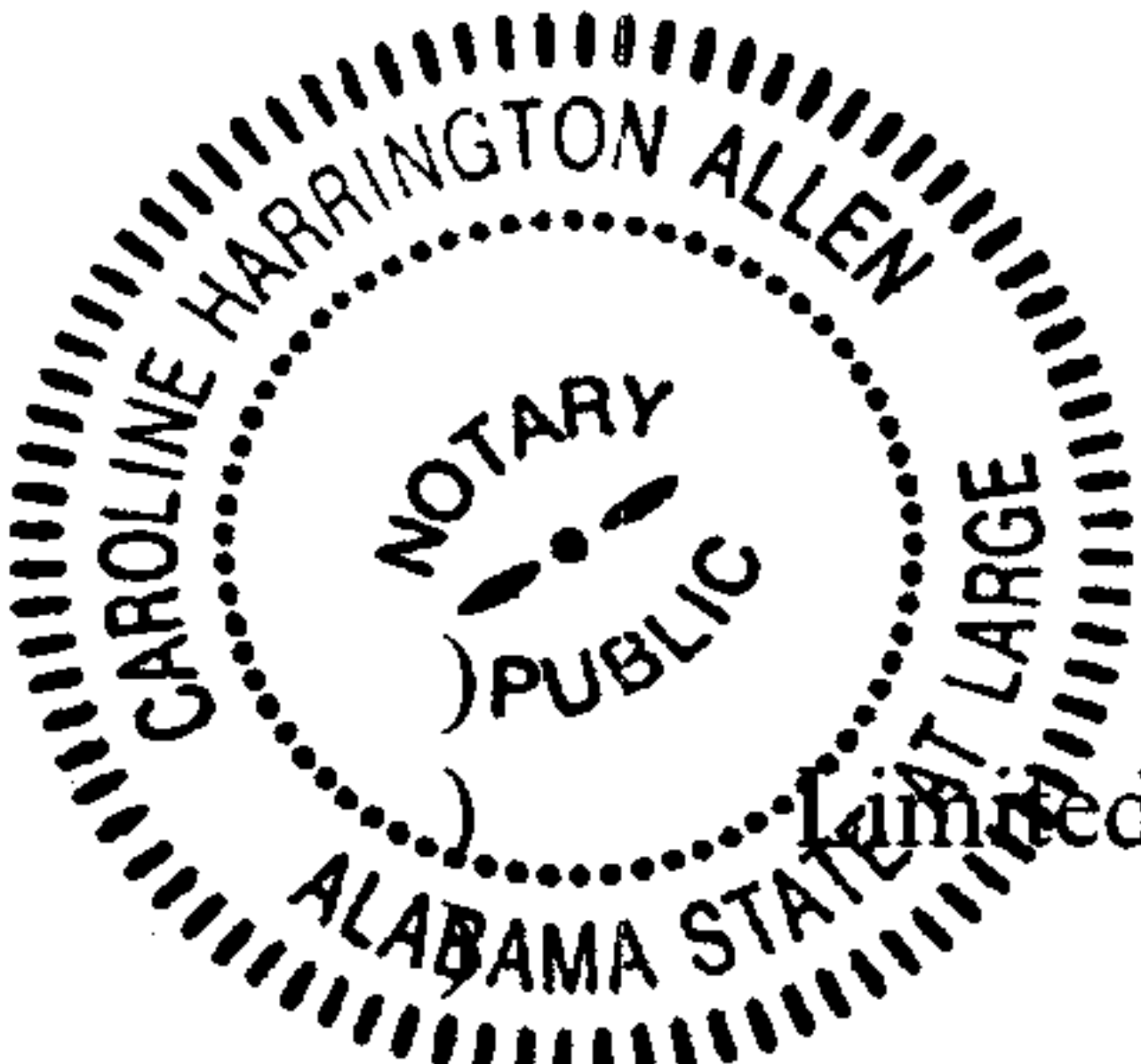
Subject to current taxes, easements, restrictions and rights-of-way of record.
