That in consideration of the sum of **One Hundred Ninety Nine Thousand Dollars and No Cents (\$199,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Kent G. Palcanis and Phoebe D. Palcanis**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Kenneth Wade Green and Lori McIntyre Green**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

Lot 170, according to the survey of Alabama Power Company Recreational Cottage Site, Sector 7, as recorded in map book 23, Page 28, in the Probate Office of Shelby County, Alabama.

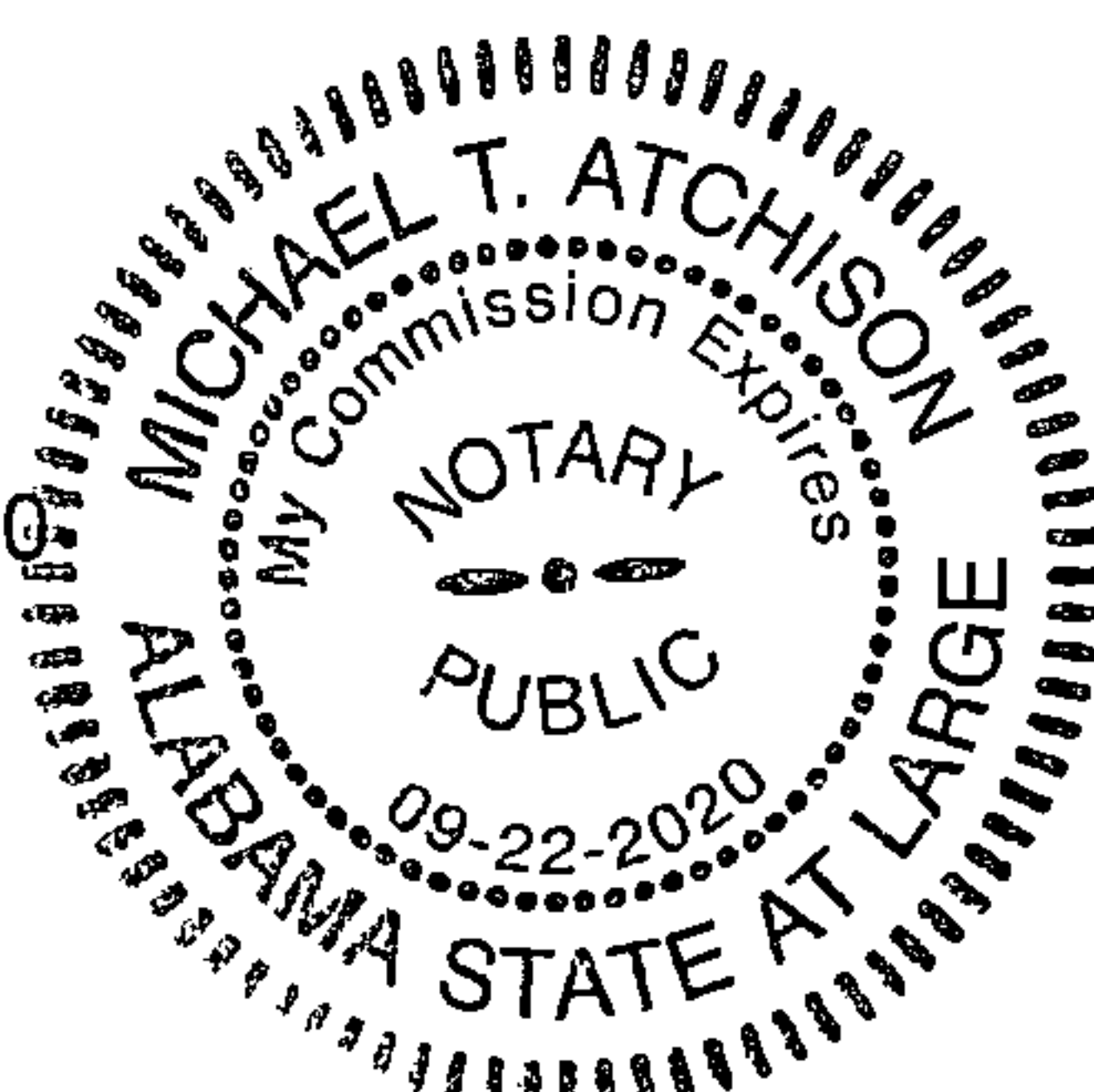
