

SUBORDINATION AGREEMENT

WHEREAS **Chris Campbell and Amanda Campbell, Husband and Wife** (hereinafter referred to as the "Borrowers" whether one or more), has applied to **Avadian Credit Union** hereinafter referred to as the "Lender") for a loan not to exceed **\$369,000.00** to be secured by a mortgage on the property hereinafter described; and

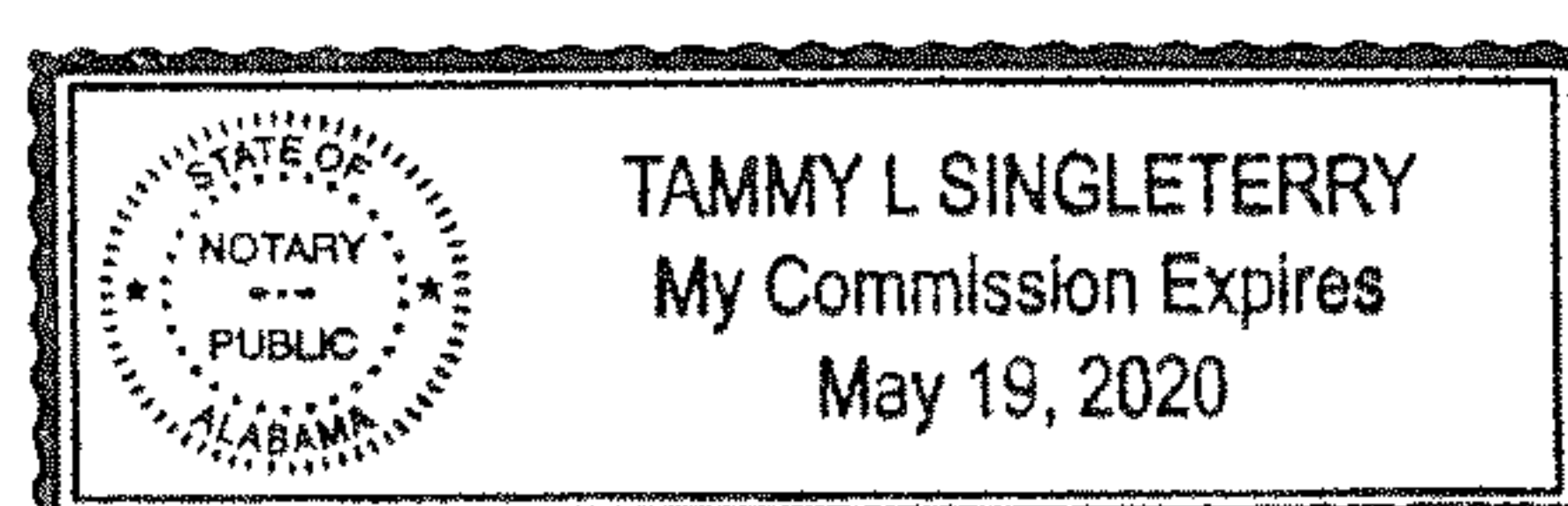
