**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS,**

That for and in consideration of **THREE HUNDRED THIRTEEN THOUSAND AND NO/100 (\$313,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **WILLIAM E. NICHOLS, III and CANDACE C. NICHOLS**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **JAMES T. WALKER and CAROL J. WALKER**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 10-08, according to the Survey of Chelsea Park, 10th Sector, as recorded in Map Book 37, Page 12, in the Probate Office of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Areas as more particularly described in the Declaration of Easements and Master Protective Covenants of Chelsea Park, a Residential Subdivision, filed for record in Instrument 20041014000566950; in the Probate Office of Shelby County, Alabama and Declaration of Covenants, Conditions, and Restrictions for Chelsea Park 10<sup>th</sup> Sector, recorded in Instrument 20061108000548430 (which, together with all amendments thereto, are hereinafter collectively referred to as the "Declaration").

Subject to:


1. General and special taxes or assessments for the year 2020 and subsequent years not yet due and payable.


