Know All Men by These Presents: That in consideration of **Two Hundred Six Thousand Eight Hundred Eighty-Five and 00/100 Dollars (\$206,885.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH BIRMINGHAM, LLC** (herein referred to as Grantor) grant, bargain, sell and convey unto **RICKY O. 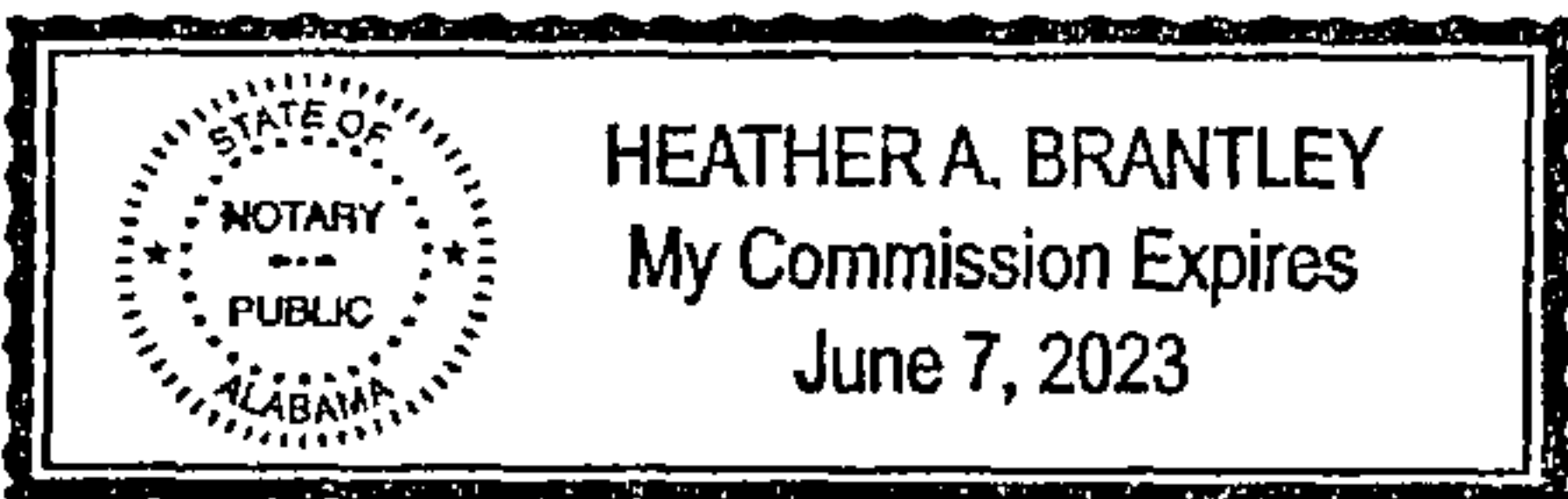

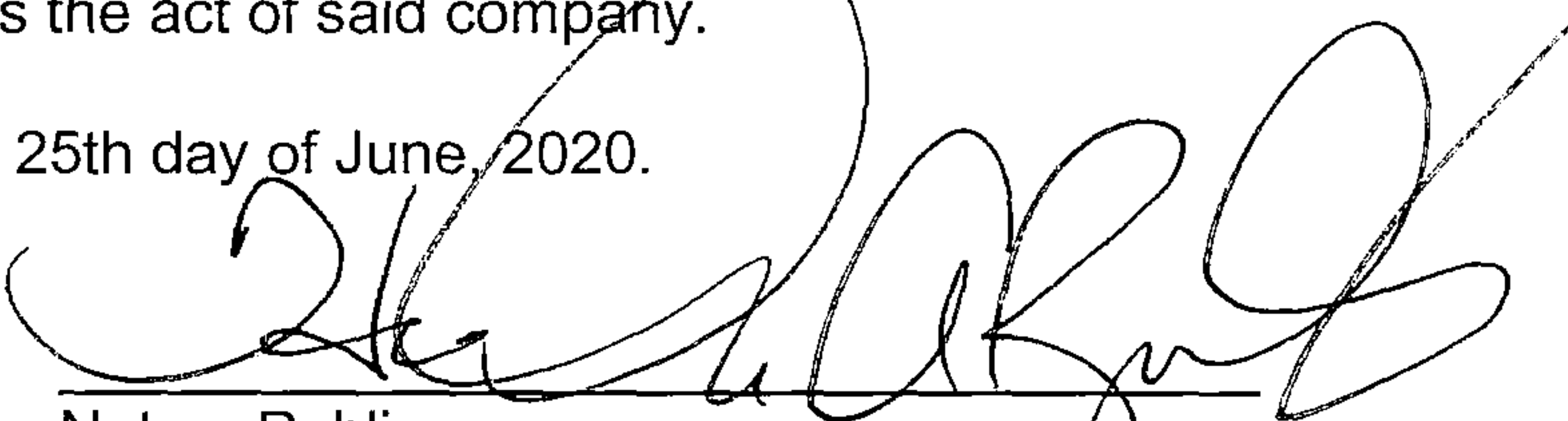

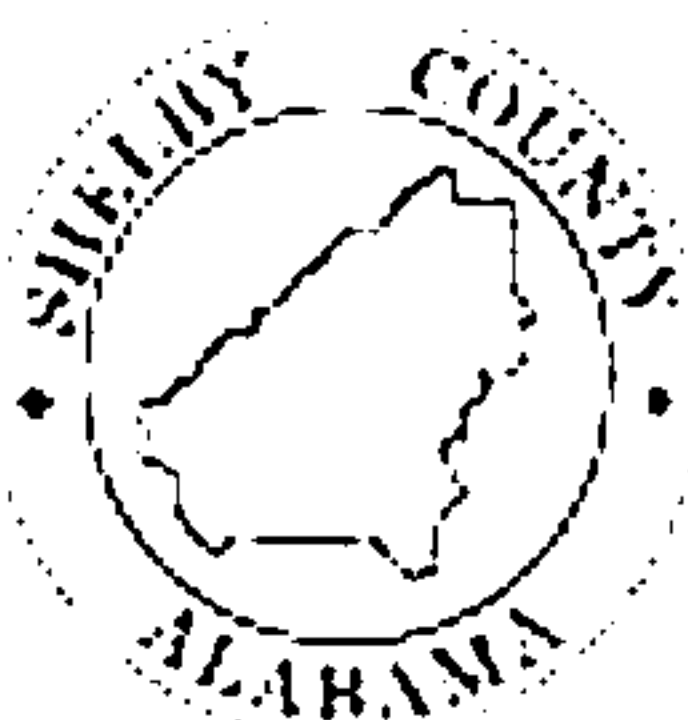
