

- k. to make gifts from time to time to my descendants and members of my family, including members of the family of my Agent, whom my Agent has reason to believe I would have wished to benefit and to purchase life, accident, and health insurance on me;
- l. to purchase or acquire in any manner whatever United States Government bonds eligible for the payment of the Federal estate tax, in whatever amount my Agent deems advisable, and to borrow from any lender at the said lender's then current interest rate in order to purchase or acquire said bonds and, if necessary, to pledge said bonds or any of my other assets as collateral for said loan;

- n. to take any necessary action to secure benefits; make election;, change options; designate, appoint and change beneficiaries due me, my husband, and heirs including from Federal civilian or military service, Social Security, Medicare, and including all other Federal, State or local Governments;
- o. to renew the registration and, if necessary, obtain one or more new license plates or stickers to be affixed on license plates for any motor vehicles to which I have title, to sell any such motor vehicles, transfer the registration and convey title to the purchaser or purchasers thereof.
- p. to waive any lawyer-client privilege I may possess, so that my Agent may obtain access to legal records and files and related information which otherwise might be privileged and could not be turned over to my Agent;

- q. to sue any person, firm or corporation for damages for refusal to honor this Durable Power of Attorney and to comply with the directions of my Agent acting hereunder;
- r. To use and apply so much of the income and principal of my assets as may be necessary, in the sole discretion of my Agent, for my health, support or maintenance;
- s. in the event of my incapacity, whether such incapacity occurs as a result of illness, accident, advanced age, or for any other reasons, if it is at all practical for me to be cared for at home, my Agent shall have power to arrange for such home care and pay all said costs, including the expenses of the round-the-clock private duty nurses or the equivalent, the rental or purchase of hospital type furniture, medical equipment and supplies (including special beds, wheel chairs, tables, bathroom fixtures, and stairs glides) as well as the temporary or permanent installation of any equipment of this nature in any home owned or rented by me;
- t. to employ, compensate and discharge medical personnel including such physicians, psychiatrists, dentists, nurses, and therapists as my Agent shall deem necessary for my physical, mental and emotional well being;
- u. in the event that I am no longer able to give directions to my health care providers or I am unable to make decisions concerning appropriate medical treatment, my Agent shall have the power to make any health care decision on my behalf that I could make for myself but for the lack of capacity. I have thoughtfully and thoroughly made my wishes known and given directions to my Agent and I specifically authorize him to make decisions regarding the provision, withholding, or withdrawing of life-sustaining treatment and artificially provided nutrition and hydration. I do hereby appoint and name my Agent, GORDON DOUGLAS JONES, as my Health Care Proxy as authorized by the Alabama Natural Death Act, Chapter 8A, Title 22, Code of Alabama 1975. For the purpose of making present or future decisions, as well as to act for me and manage my affairs I hereby authorize my Agent, regardless of my ability to give directions to my health care provider, to waive any doctor-patient privilege I may possess, to request, review, and receive any information, oral or written, regarding my physical or mental health,



including medical and hospital records, execute a release or other document required to obtain the information, and consent to the disclosure of the information.

The specifically enumerated powers in the paragraphs above are in aid, in addition, and in exemplification of the full, complete, and general power herein granted and are not in limitation or definition thereof.

If GORDON DOUGLAS JONES for any reason fails to accept this appointment as my Agent or having accepted such appointment shall become incapacitated, become no longer qualified to serve, die or resign, in such event, I appoint TERRIE J. SAVAGE of Hartselle, Alabama to be my Agent with full, complete general authority and power as enumerated above to act and make decisions for me.

This Power of Attorney has been granted by me with the expectation that my said Agent may desire to file this Durable Power of Attorney for record in the Probate Court of Shelby County, Alabama, or to exhibit copies to any person with whom she deals hereunder. In the event that either or both are done, any person, including my Agent, may rely upon the validity of this Power of Attorney or a copy of it unless that person knows it has terminated or is invalid and I hereby ratify and confirm whatsoever my Agent shall lawfully do or cause to be done by authority of this instrument.
