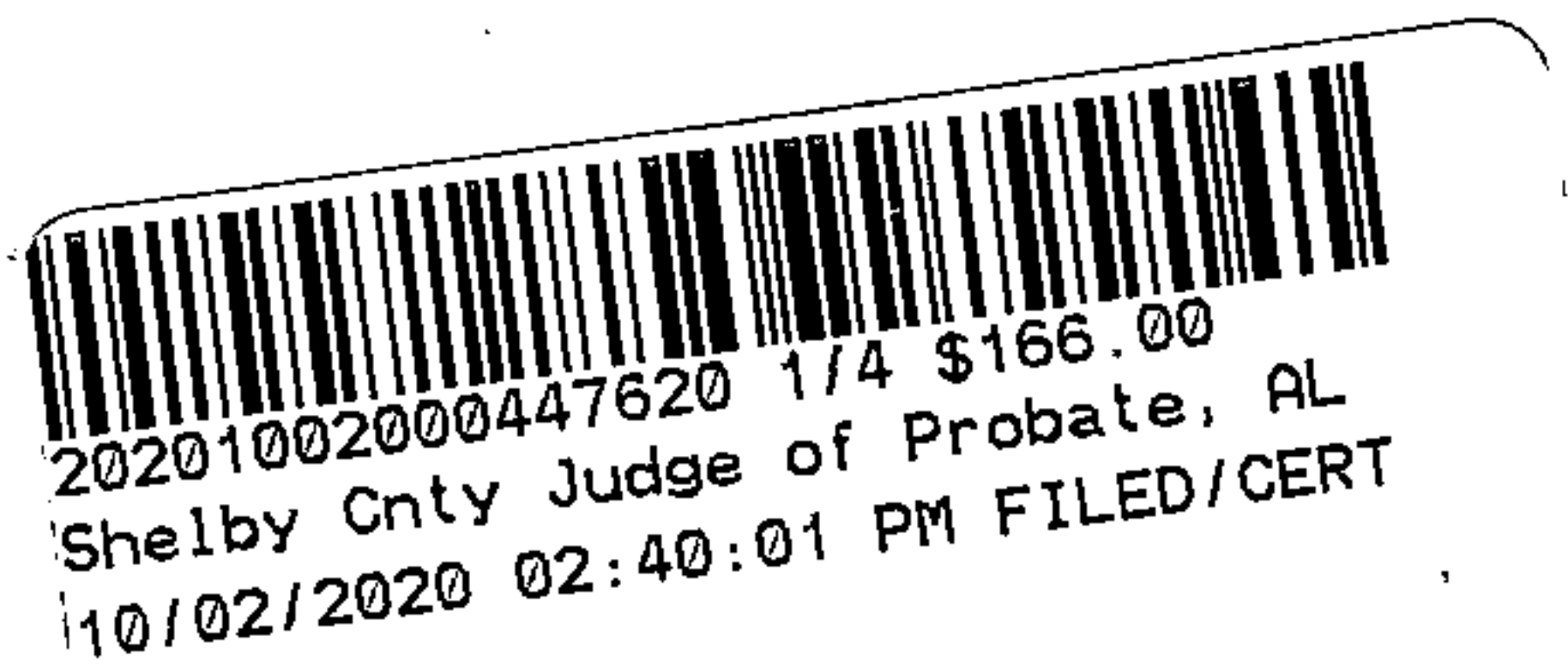

CERTIFICATE OF FORMATION
OF C & G HANDYMAN SERVICES, LLC

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, hereby certify as follows:

1. Name of Limited Liability Company. The name of the Limited Liability Company being formed is C & G Handyman Services, LLC.

2. Name Reservation. A copy of the Name Reservation Certificate from the Office of the Secretary of State of Alabama is attached hereto, and the name reserved is C & G Handyman Services, LLC.

3. Registered Agent and Office. The name of the registered agent is Carolyn Gallups, and the street and mailing address of the registered office is 11721 Highway 61, Wilsonville, Alabama 35186.

4. Members. There is at least one (1) Member of the Limited Liability Company, and the names and addresses of the Members are as follows: Carolyn Gallups, 11721 Highway 61, Wilsonville, Alabama 35186; and Christopher Abbott, 11944 Highway 61, Wilsonville, Alabama 35186.

5. Purposes. The purposes of the Limited Liability Company are to (a) engage in handyman services, including, cleaning, flooring, framing, trim work, installation and repair of windows and doors, tile work, sheetrock work, painting, electric work, and general residential and commercial construction and repair; (b) conduct, undertake and carry on any business, transactions, or operations commonly undertaken or carried on by retail and wholesale businesses, service providers, contractors and subcontractors, property owners or developers, and generally to enter into, carry on, assist, promote or participate in financial, commercial, mercantile, and other business works, contracts, undertakings and operations; (c) purchase, take, receive, subscribe for, acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, limited liability companies, individuals, and direct or indirect obligations of governmental entities or of any

instrumentality thereof; (d) lend or borrow money, invest and reinvest funds, enter into contracts, acquire and dispose of, and take and hold real and personal property, including as security for payment of funds loaned or invested; (e) design, build, repair, and alter residential, rental, and commercial structures or buildings, and any part or contents thereof, and manage, develop, improve and subdivide real property into residential or business subdivisions; (f) act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction; and (g) engage in any and all other business permitted under the laws of the State of Alabama.

6. Effective Date. This Certificate of Formation, and the formulation and filing of the Limited Liability Company, is effective immediately on the date filed with the Judge of Probate of Shelby County, Alabama.

7. Duration. The existence of this Limited Liability Company shall continue until it is dissolved as provided in the Limited Liability Company Agreement, or if no provision therein governs the duration of the Company, as may be provided by the Alabama Limited Liability Act. The cessation or ending of membership of one or more Members will not result in the dissolution of the Limited Liability Company.

8. Management. The Limited Liability Company shall be managed by its Members, or as may hereafter be permitted.

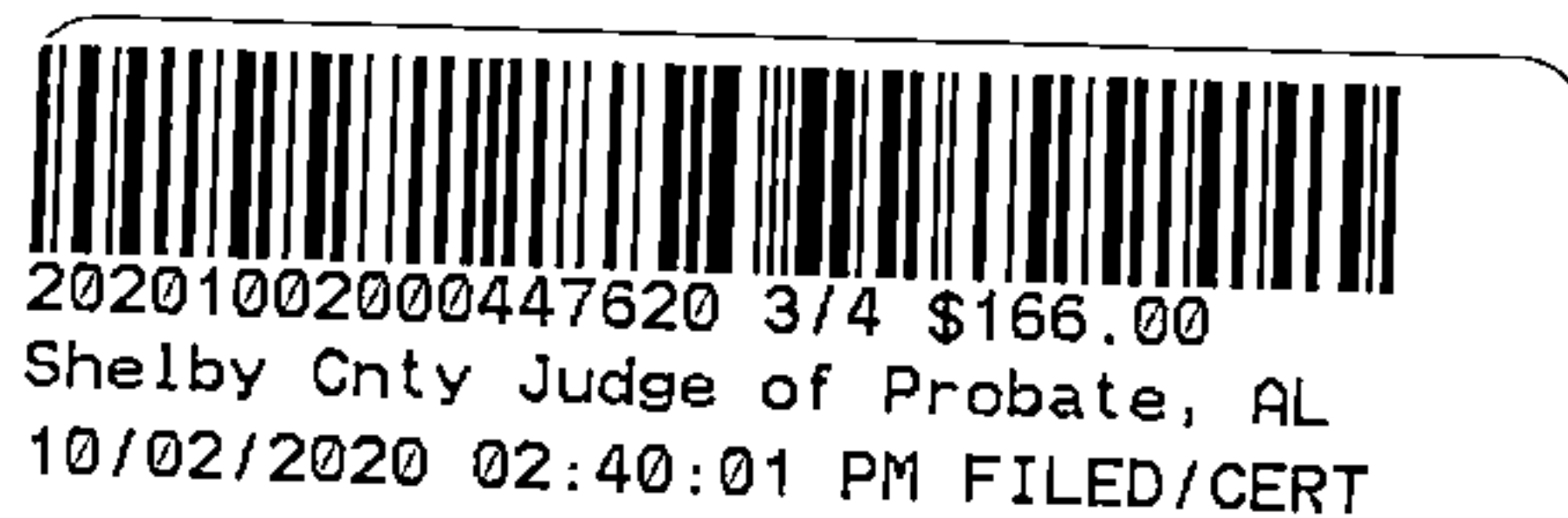
