SUBORDINATION AGREEMENT

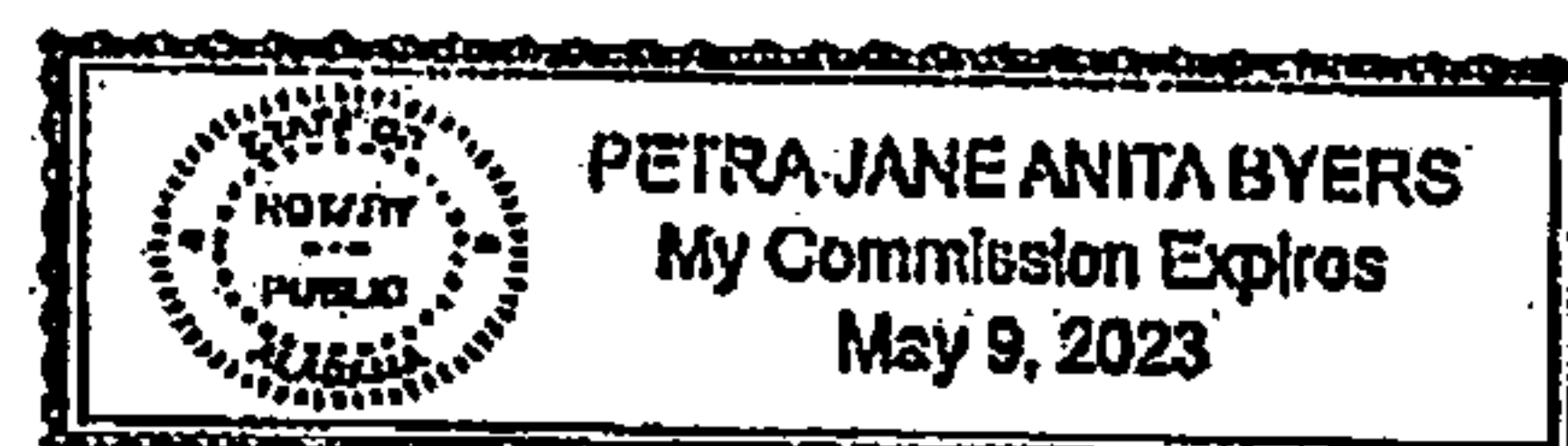
