## OATH OF OFFICE

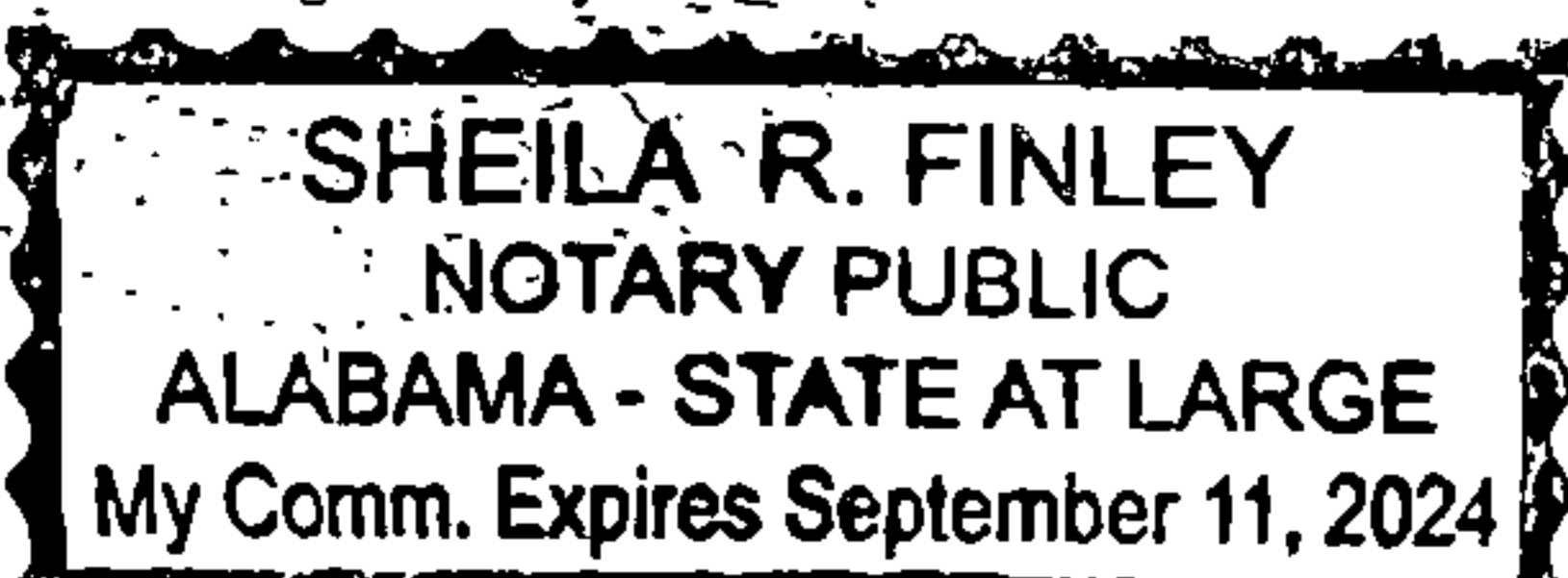

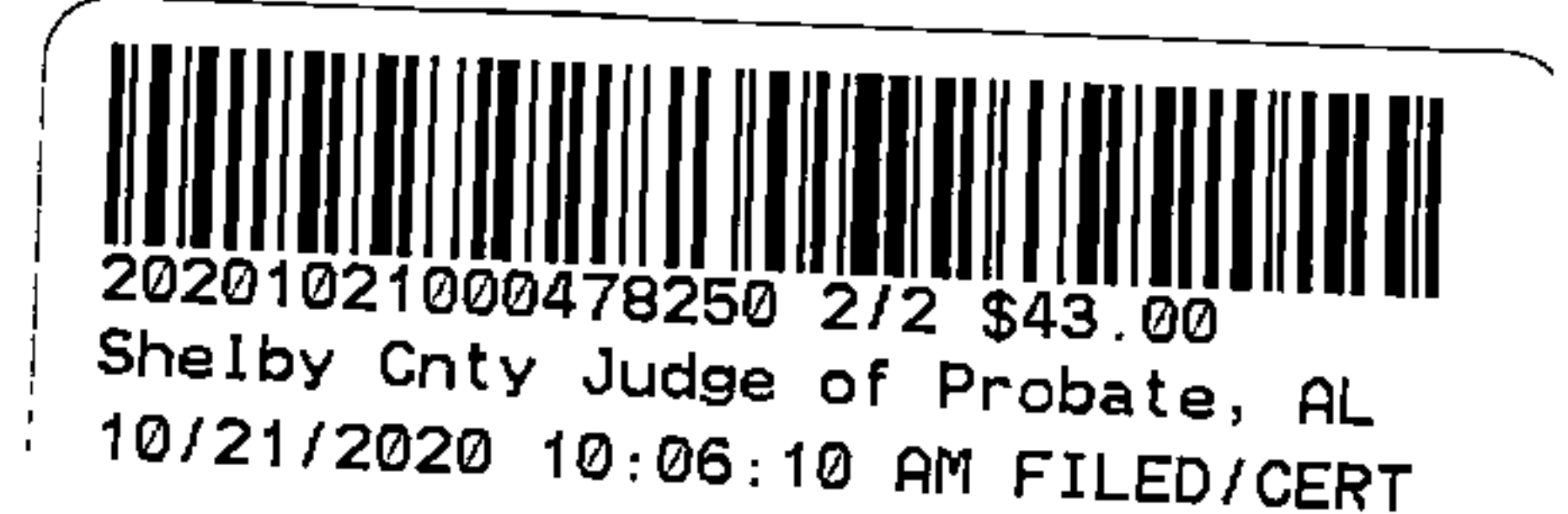
