LIMITED POWER OF ATTORNEY

This Limited Power of Attorney is dated as of July 15, 2020, by MTGLQ Investors, L.P., having an office at 200 West Street, New York, New York 10282 ("MTGLQ"), appointing as attorney-in-fact ServiceLink NLS, LLC, having an office at 1400 Cherrington Parkway, Moon Township, Pennsylvania 15108 ("Entity").

KNOW ALL MEN BY THESE PRESENTS, that MTGLQ, pursuant to that Master Services Agreement between MTGLQ and the Entity, dated as of October 11, 2016 (the "Agreement"), hereby constitutes and appoints the Entity, MTGLQ's true and lawful Attorney-in-Fact, in MTGLQ's name, place and stead and for MTGLQ's benefit, in connection with all REO properties subject to the terms of the Agreement (the "Assets") for the purpose of performing all acts and executing all documents in the name of MTGLQ as may be reasonably necessary and appropriate to effectuate any of the following enumerated circumstances:

to draft, execute and record on behalf of MTGLQ any deeds, assignments, allonges, endorsements and documents necessary to assign, convey, or otherwise transfer MTGLQ's interest in the Assets, and all other comparable instruments, with respect to the Assets or related mortgaged real property, with all acknowledgments, affidavits, and supporting documents as may be necessary or required to effect execution, delivery, conveyance, recordation or filing of any of foregoing documents.

The undersigned gives said Attorney-in-Fact full power and authority to execute such instruments and to do and perform all and every act and thing necessary and proper to carry into effect the power or powers granted by or under this Limited Power of Attorney, each subject to the terms and conditions set forth in the Agreement as fully as the undersigned might or could do, and hereby does ratify and confirm to all that said Attorney-in-Fact shall lawfully do or cause to be done by authority hereof.

Capitalized terms used herein without definition have the meanings ascribed to them in the Agreement.

If the Entity receives any notice of suit, litigation or proceeding in the name of MTGLQ, then the Entity shall promptly forward a copy of same to MTGLQ.

This Limited Power of Attorney shall terminate one (1) year from the date hereof.

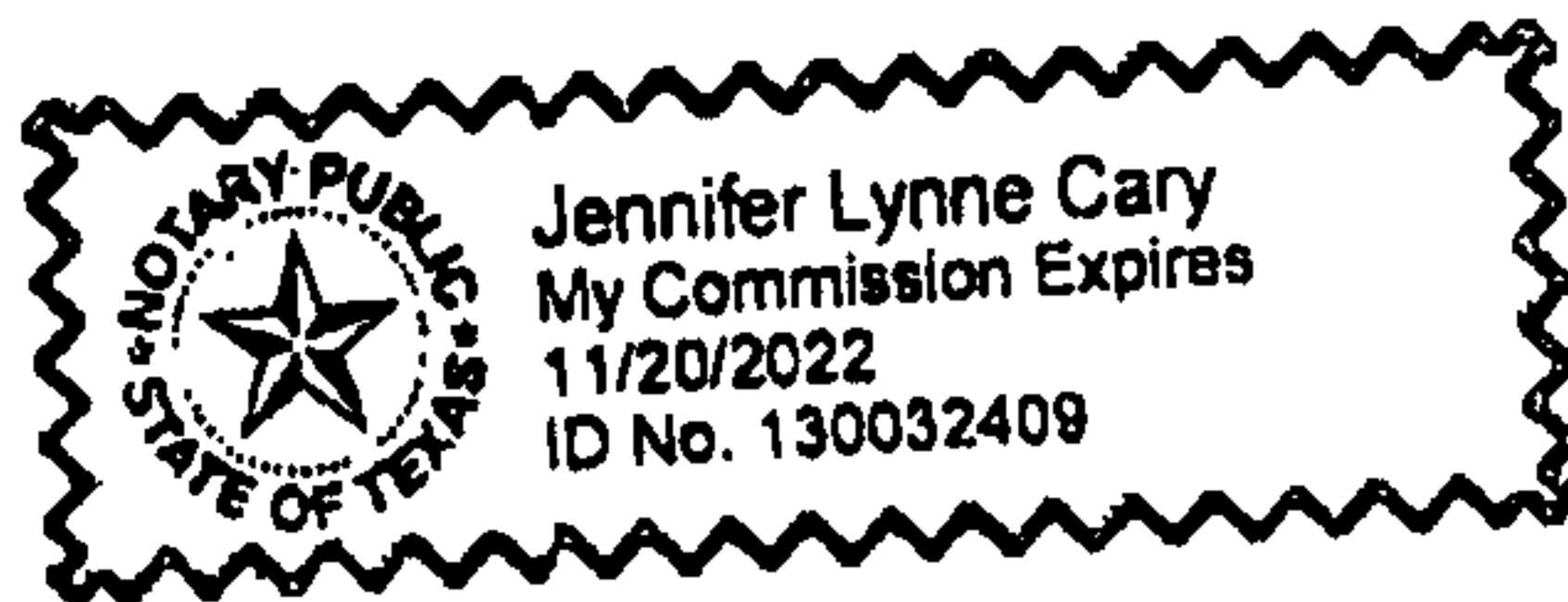
