

# LAST WILL AND TESTAMENT OF Myra Kay Reeves also known as (Kay L Reeves)

I, Kay L Reeves, an adult residing at Shelby County, Vincent, AL, being of sound mind, declare this to be my Last Will and Testament. I revoke all wills and codicils previously made by me.

### ARTICLE I APPOINTMENT OF PERSONAL REPRESENTATIVE

I appoint my said daughter, Lisa K. Patterson as my Personal Representative to administer this Will and ask that she be permitted to serve without Court supervision and without posting bond. If my said daughter Lisa K Patterson is unwilling or unable to serve, then I appoint my said son Kenneth "Dewayne" Diffy to serve as my Personal Representative and ask that he be permitted to serve without Court supervision and without posting bond.

## ARTICLE II PAYMENT OF CLAIMS AND EXPENSES

I direct my Personal Representative to pay out of my residuary estate all of the expenses of my last illness, administration expenses, all legally enforceable creditor claims, all Federal estate taxes, state inheritance taxes, and all other governmental charges imposed by reason of my death without seeking reimbursement from or charging any person for any part of the taxes and charges paid, and if necessary, reasonable funeral expenses, including the cost of any suitable marker for my grave, without the necessity of an order of court approving said expenses.

### ARTICLE III FIRST DEVISE

I devise, bequeath, and request that any personal property that was given to me as a gift throughout the years be returned to the child (Dewayne, Lisa, Jackie, Dana & Lana) and/or grandchild that I received it from. If that child does not want a particular item that they gifted, one of the others may have it upon agreement from other children. If no agreement can be made, then it will be up to my personal representatives to choose a fair way to decide.

I devise, bequeath, and give listed below specific itemized personal property:

Lisa Patterson Master Bedroom Suite

Lana Smith Small Kitchen Appliances and Matching Living Room Suite (not including recliner)


Jackie Reeves Storage building that is already installed/connected to Jackie's property and the family bible.

### ARTICLE IV RESIDUAL DEVISE

#### SELF-PROVING AFFIDAVIT

Under penalties for perjury, we, the undersigned Testator/Testatrix and witnesses declare:

- 1. That the Testator/Testatrix executed this instrument as his/her Will.
- 2. That in the presence of witnesses, the Testator/Testatrix signed or acknowledged his/her signature already made, or directed another to sign for him/her in his/her presence.
- 3. That the Testator/Testatrix executed the Will as his/her free and voluntary act for the purposes expressed in it.
- 4. That each of the witnesses, in the presence of the Testator/Testatrix and of each other, signed the Will as witness.
- 5. That the Testator/Testatrix was of sound mind; and
- 6. That, to the best of his/her knowledge, the Testator/Testatrix was at the time eighteen (18) or more years of age.
