


Subject to a third party mortgage in the amount of \$700,000.00 executed and recorded simultaneously herewith.

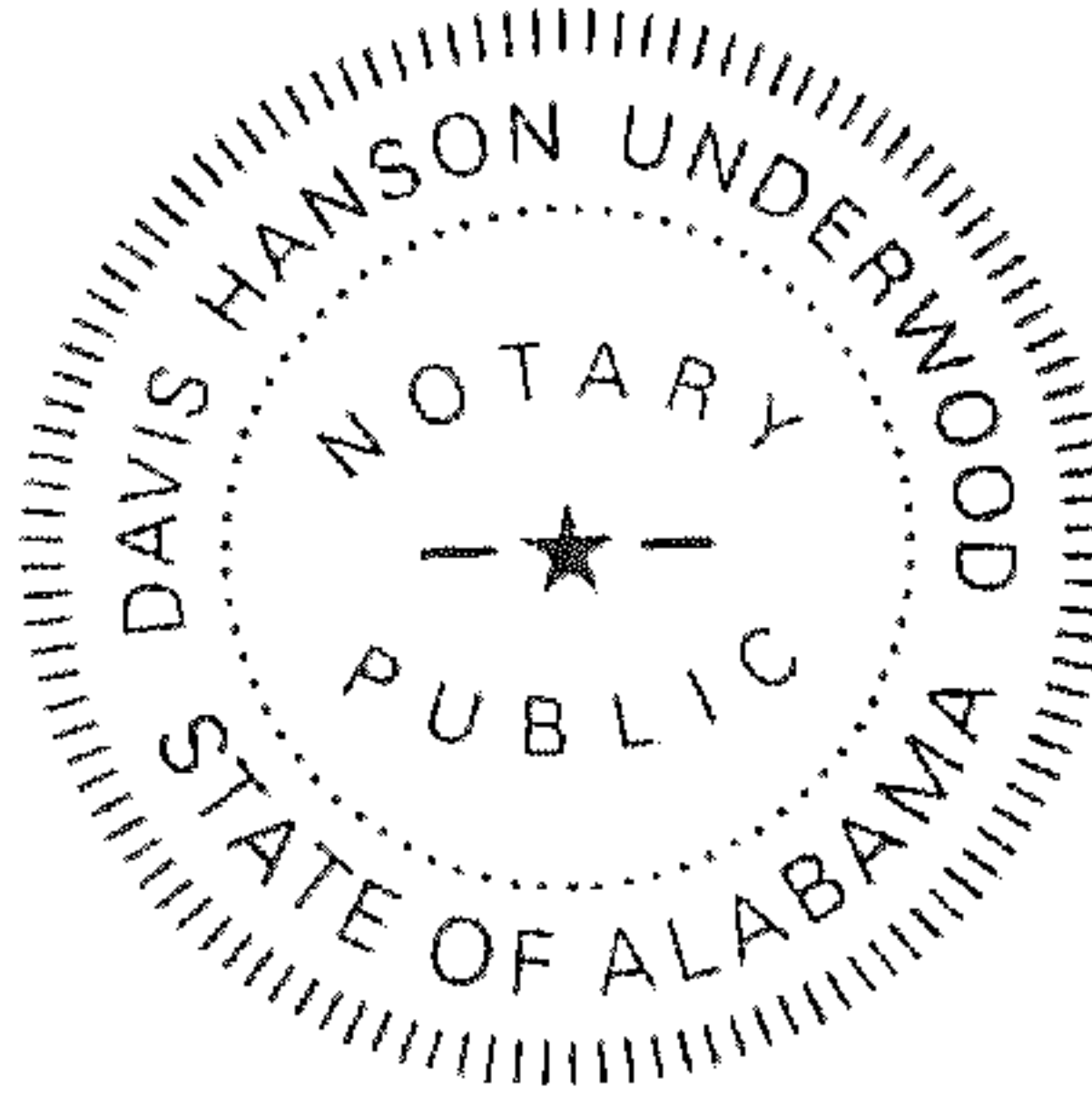
