WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this May 6, 2021, That for and in consideration of **TWO HUNDRED NINE THOUSAND AND NO/100 (\$209,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **DWAYNE J. RIGSBY and HOLLY Y. RIGSBY, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **ZACHARY J. EARNEST and ASHLEY E. TEAGUE**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 527, according to the Survey of Forest Lakes, Sector 5, as recorded in Map Book 34, Page 122 A, B and C, in the Office of the Probate Judge of Shelby County, Alabama.

Subject to:

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 34, Page 122.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


