Motes, Husband and wife** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Andy Ward and Nicole Ward**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;


\$225,000.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.



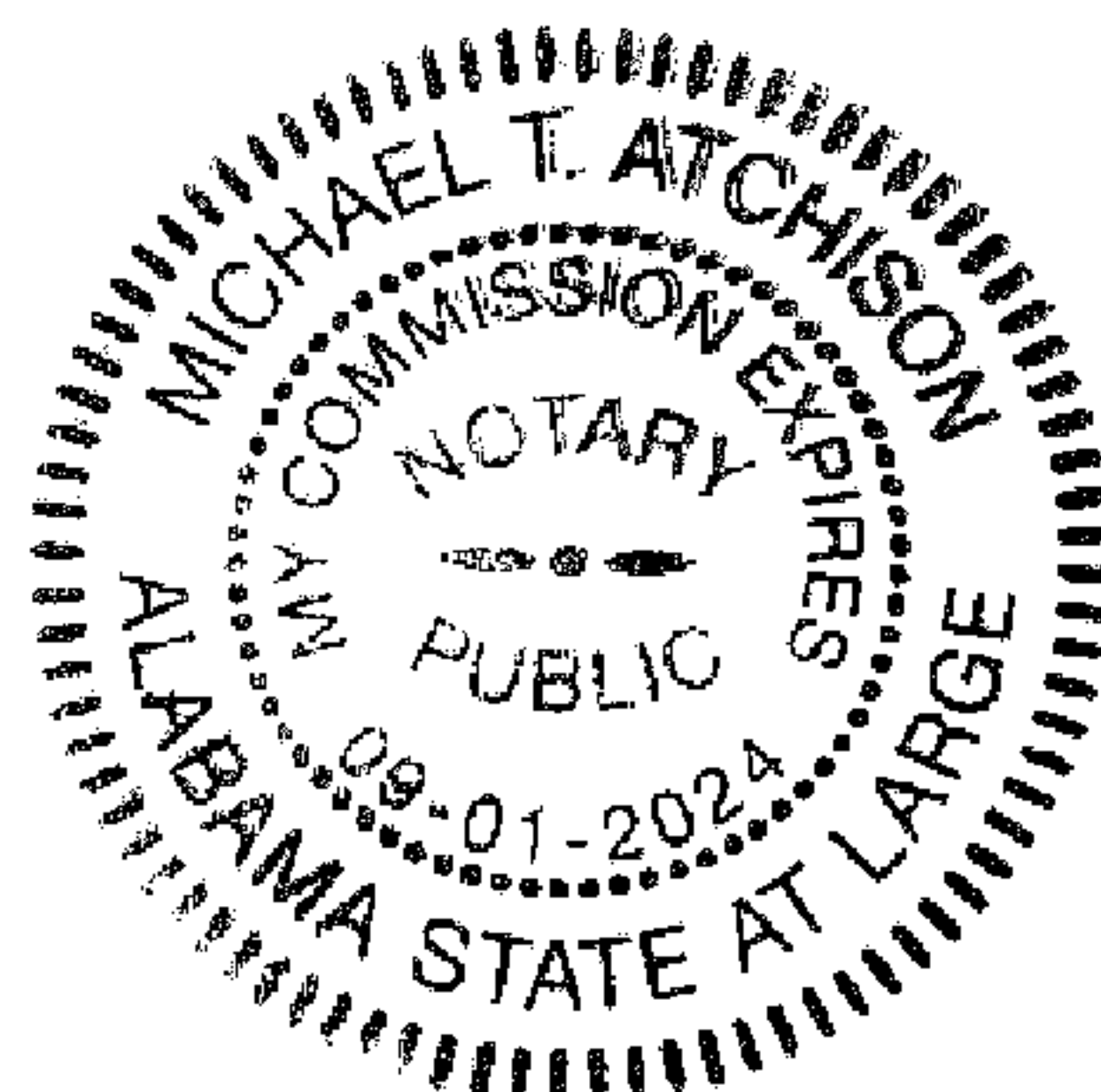
