





**POWER OF ATTORNEY

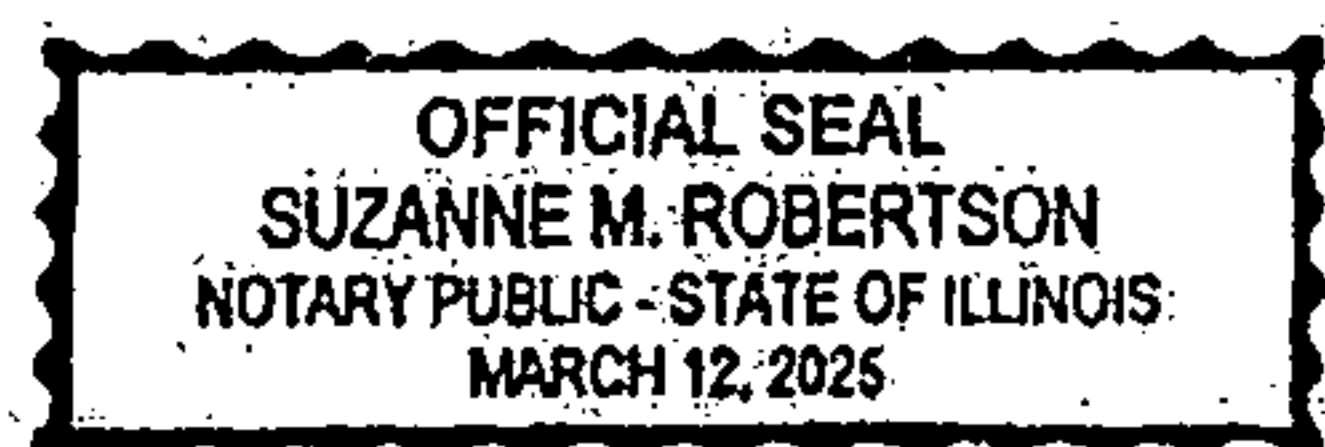
