That in consideration of **ONE HUNDRED EIGHTY TWO THOUSAND AND 00/100 DOLLARS** (\$182,000.00) to the undersigned grantor, **Rausch Coleman Homes Birmingham, LLC**, as Successor in Interest to **RC Birmingham, LLC** by Plan of Merger filed in the Office of the Secretary of State of Alabama on March 12, 2021 LLC, an Alabama Limited Liability Company, (herein referred to as GRANTOR) in hand paid by the grantees herein, the receipt whereof is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto **Coby Brage Mize and Yurenia Rodriguez**, (herein referred to as Grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

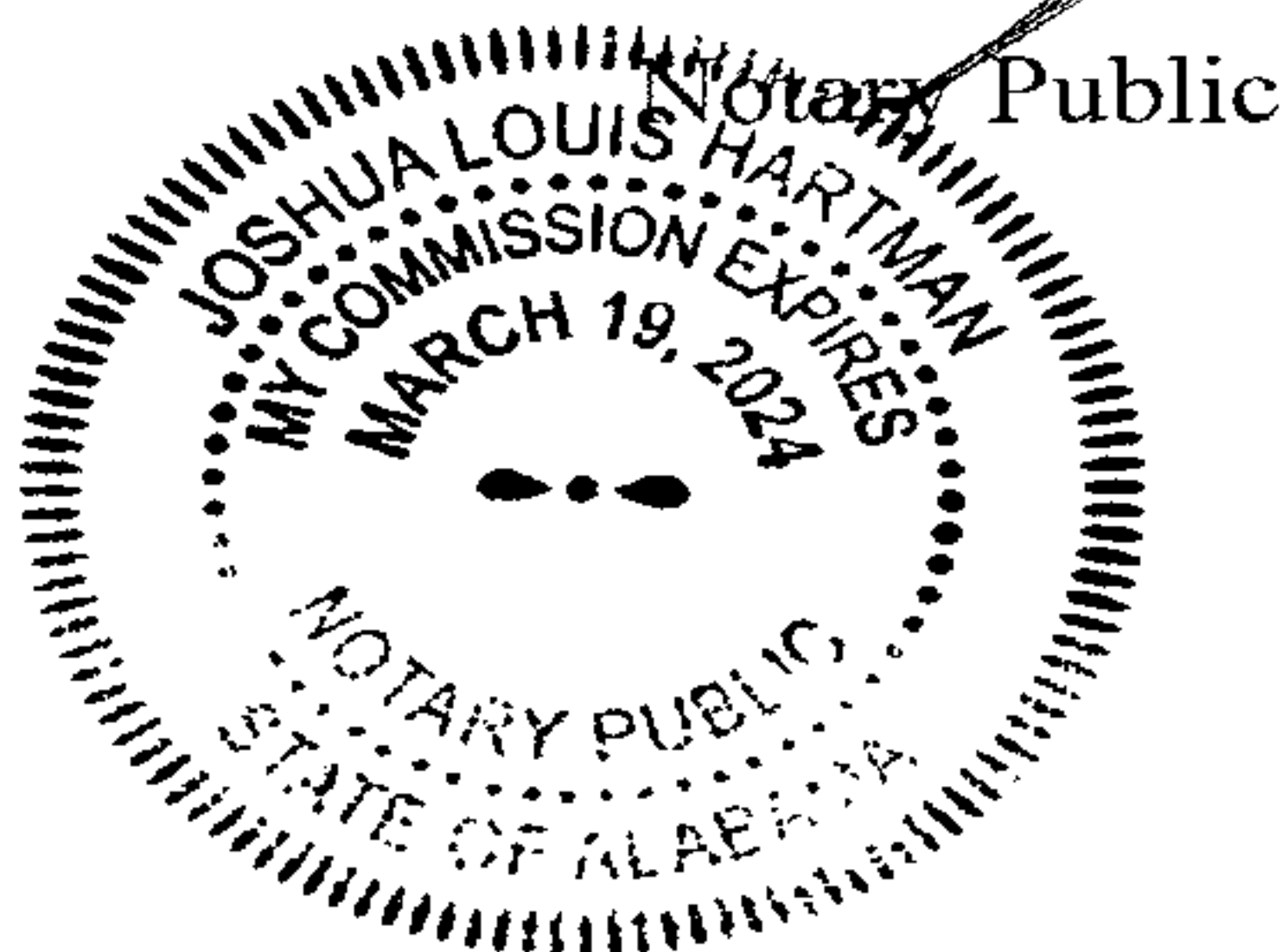

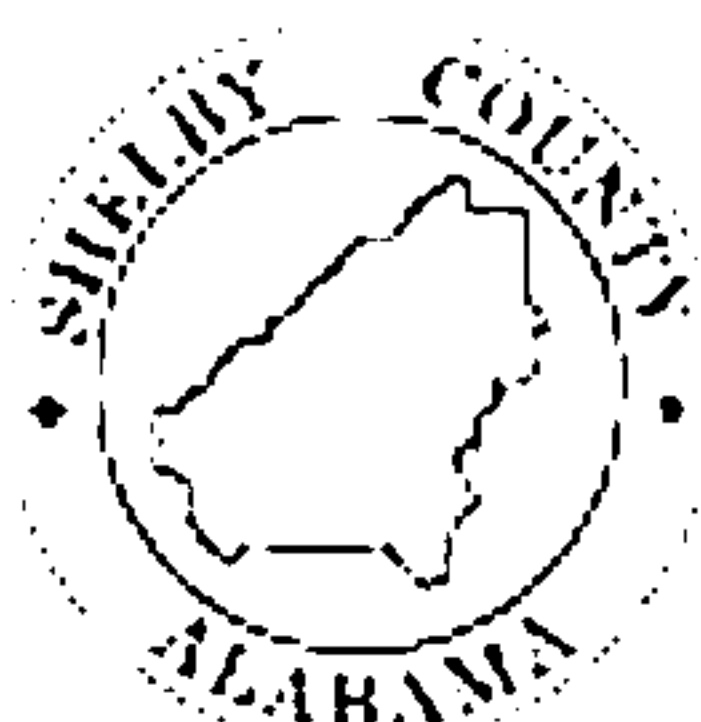
