This matter came before the Court on September 13, 2021 for hearing on the Petition for Final Settlement filed by Western Surety Company, as Surety for Wendy T. Jennings, Personal Representative of the Estate of Jennett Daline Jennings, deceased. Notice was given as required by law. The case was called and the Court proceeded to review the documents and supporting evidence filed in this matter.

On or about December 23, 2015 this Court issued Letters of Administration with Will Annexed to Wendy T. Jennings ("Personal Representative") upon the posting of a Bond in the amount of Ten Thousand Dollars (\$10,000). The Personal Representative was Ordered to file an Inventory within two months of her appointment. No Inventory was ever filed. The Personal Representative was sent a notice to file and Annual or Final Settlement on December 7, 2017. No Annual or Final Settlement was filed and while the Court notes several appearances by both the Personal Representative and her attorney of record in 2018, no Annual or Final Settlement was filed. The Court entered an Order for the Personal Representative to file an Annual or Final Settlement within thirty (30) days on February 26, 2021. The case was set on the Court's NonCompliance Docket on May 11, 2021for failure to file a Settlement as Ordered. The Personal Representative failed to appear for the hearing and the Court entered an Order for the Bonding Company to File a Final Settlement. The Bonding Company filed a Final Settlement on May 24, 2021.

Upon examination of the allegations set forth in the petition, the Court FINDS as follows:

- 1. The sole asset of the Estate was a parcel of real property (Parcel No.: 33 1 01 0 001 001.005) located in Shelby County, Alabama which is currently assessed to the Personal Representative and Terry E. Jennings.
- 2. There are no claims filed in the estate.
- 3. The heirs and next of kin of the Estate appear to be:
