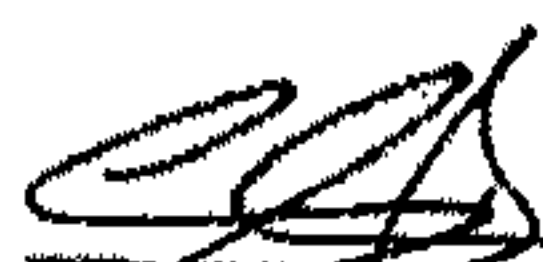
IN THE SMALL CLAIMS COURT OF SHELBY COUNTY, ALABAMA
