FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, October 26, 2015, Clinton Mallory and Maggie L. 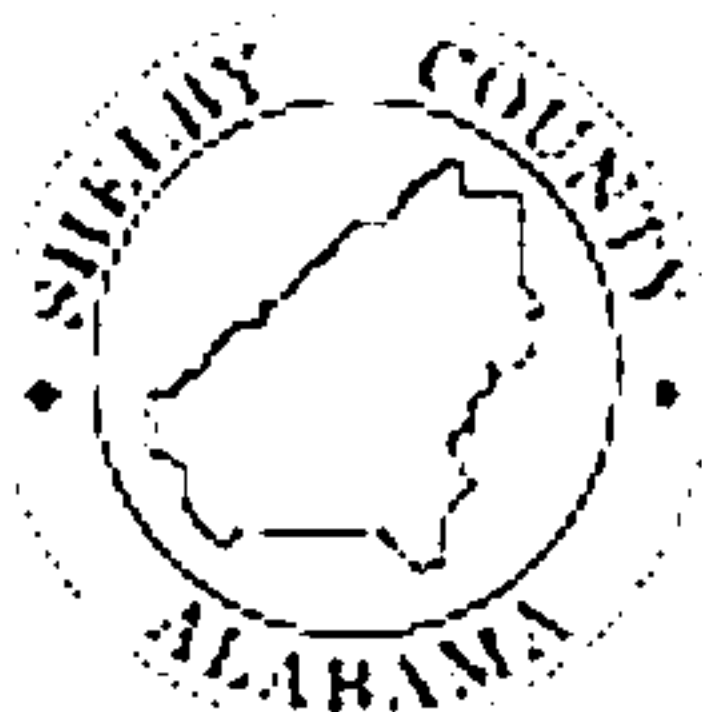
