That in consideration of **Three Hundred Eight Thousand Six Hundred Forty-Five and 00/100 (\$308,645.00)** Dollars and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

**D.R. Horton, Inc. - Birmingham**  
(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

**James T Hughes, V and Alexis M Hughes**  
(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **SHELBY** County, Alabama, to-wit:

**Lot 1715, according to Plat of Chelsea Park 17th Sector, recorded in Map Book 54, Pages 23A and 23B, of the Probate Office of Shelby County, Alabama.**

Mineral and mining rights excepted. Subject to: current taxes, conditions, covenants, easements and restrictions of record.

This covenant and agreement shall run with the land conveyed hereby as against Grantees, and all persons or entities holding under or through Grantees.

Grantor makes no warranty or covenant respecting the nature of the quality of the title to the property hereby conveyed other than that the Grantor has neither permitted or suffered any lien, encumbrance or adverse claim to the property described herein since the date of acquisition thereof by the Grantor.

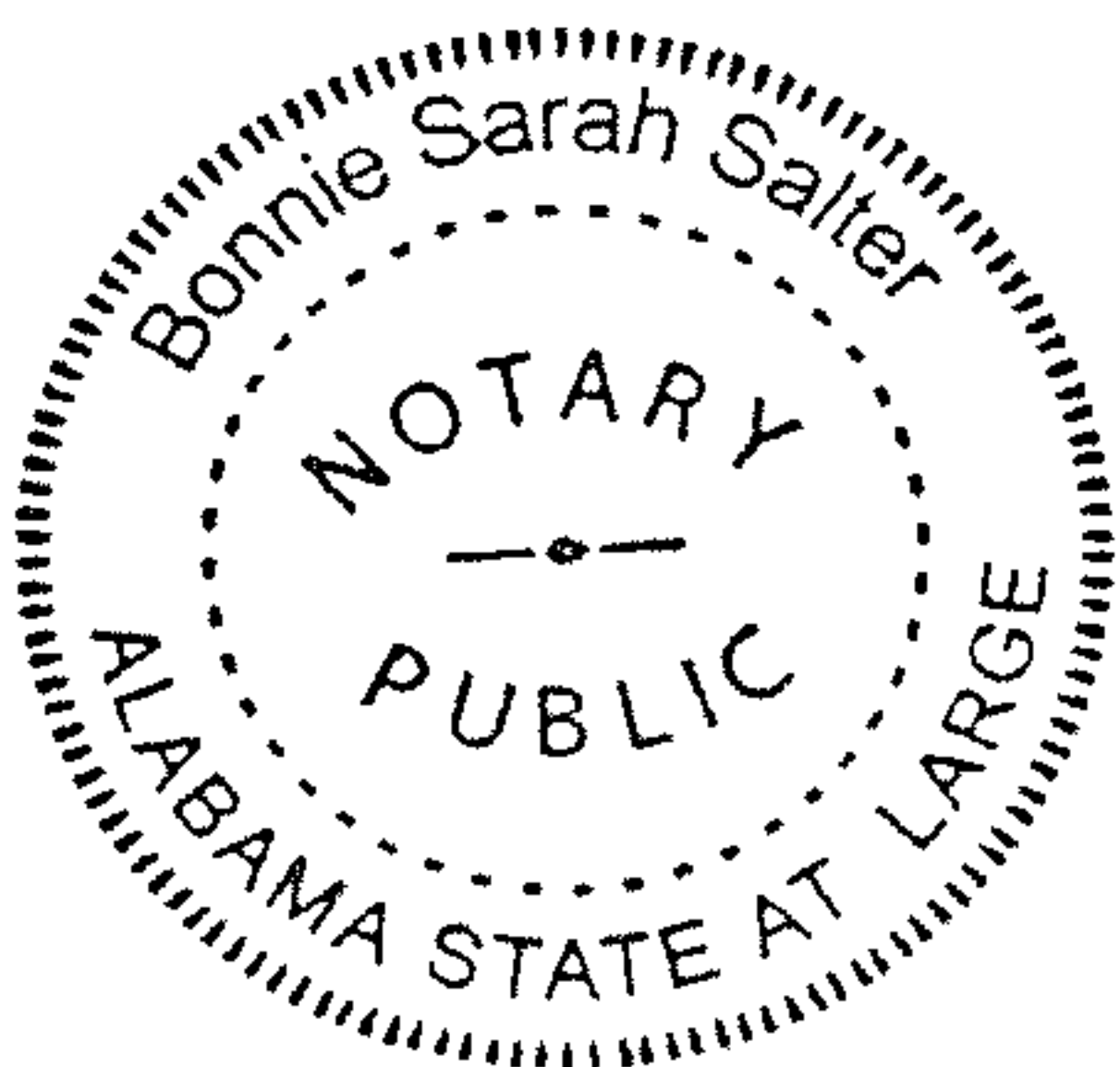


