Furthermore, nothing herein shall be deemed a release or waiver by FDIC-R of any other right and/or remedy against Watkins, Thomas and Tate secured and/or evidenced by the Judgment or COJ and all such rights and remedies are expressly reserved.

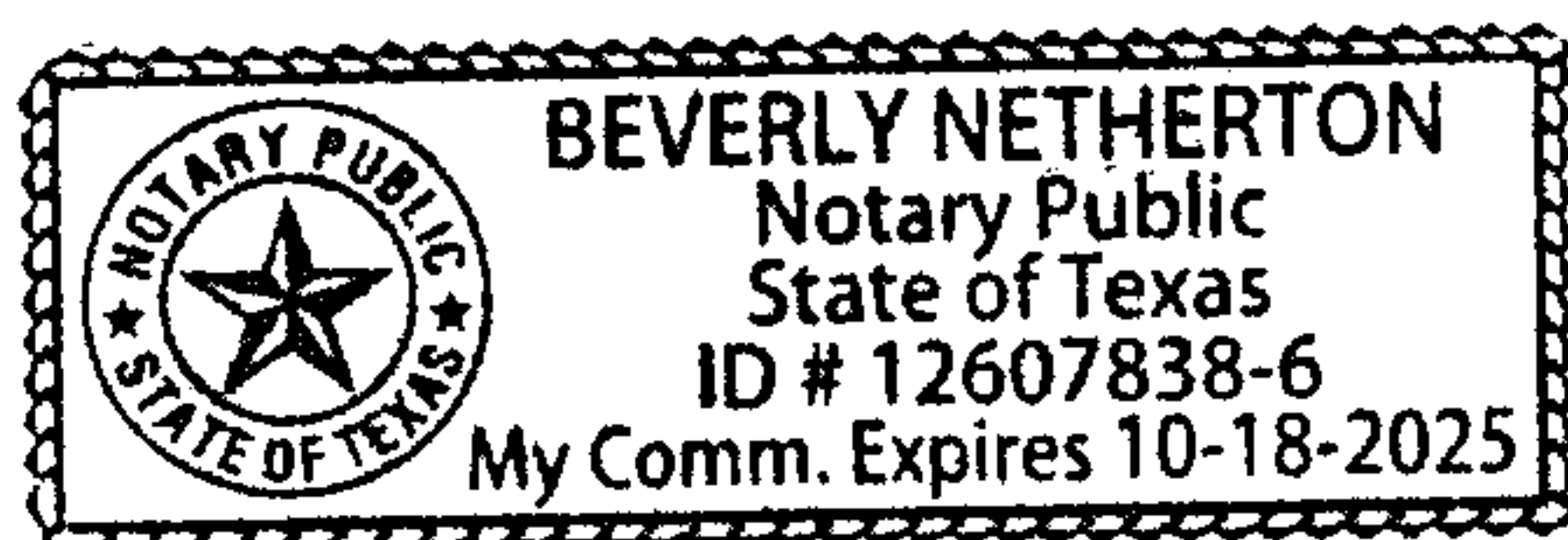
