Lot 6, according to the Survey of Fernwood Second Sector, as recorded in map Book 5, Page 63, in the Probate Office of Shelby County, Alabama.





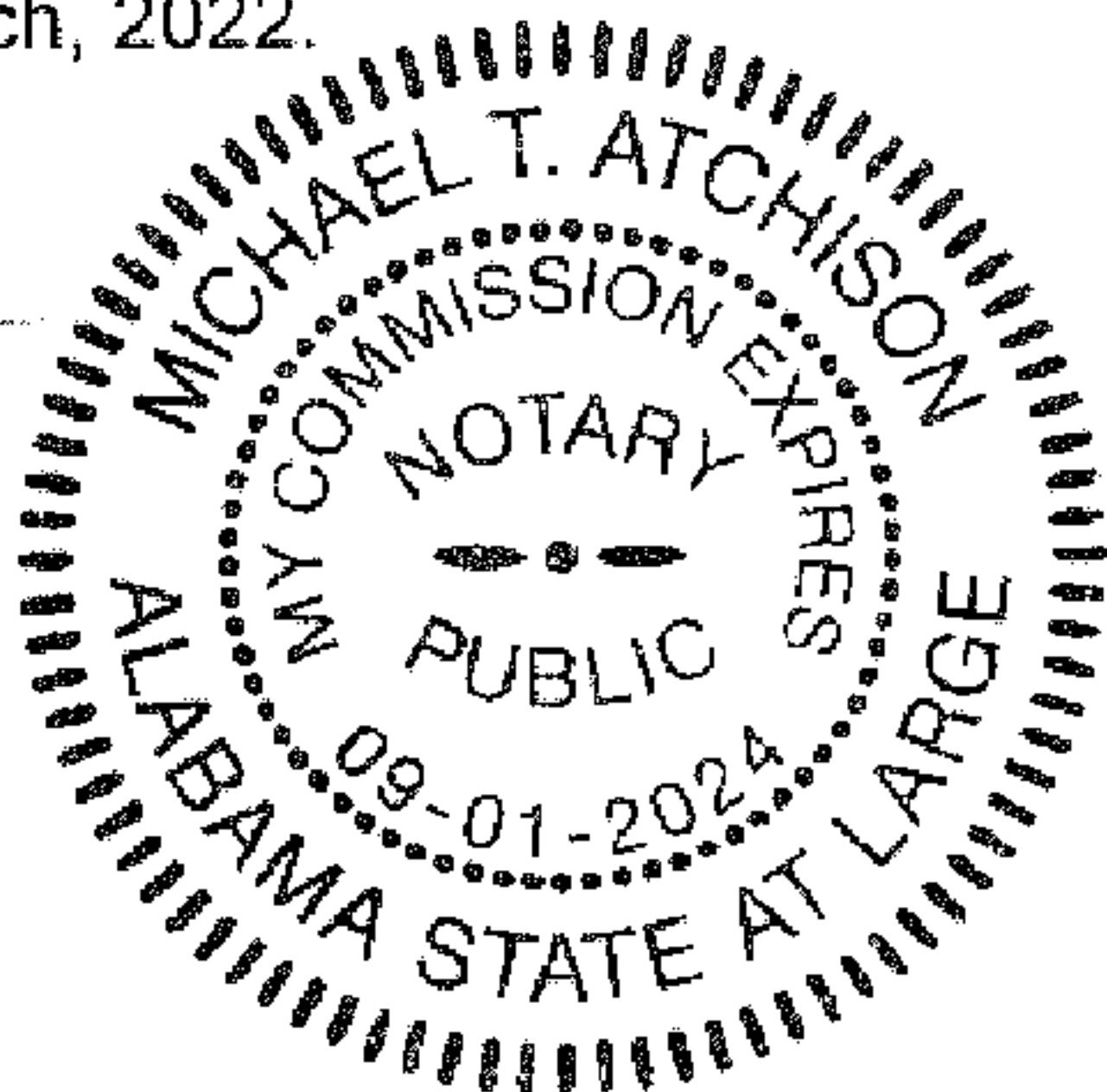
