

TRUST CERTIFICATION

The undersigned trustee certifies the following

1. The Trust for the Benefit of Susan Patrice Green created by the Last Will and Testament of Nancy B. Green, deceased, which was dated November 3, 2016, and which was admitted to probate in the Probate Court of Shelby County, Alabama, by decree entered September 16, 2020, Case No. PR-2020-000578 (the "Trust") exists, and has since inception, under Alabama law.
2. The Trust was settled by Nancy B. Green in her Last Will and Testament.
3. Letters testamentary were issued to Patsy Barnes Hyde, as personal representative of the Estate of Nancy B. Green, deceased, (the "Estate") on September 16, 2020.
4. Patsy Barnes Hyde is the sole trustee of the Trust (the "Trustee"). The Trustee's address is 1180 Haven Road, Birmingham, Alabama 35242.
5. The Trust is irrevocable.
6. The Trustee alone has the authority to sign documents and instruments conveying Trust assets.
7. The Trust was funded with the residue of the Estate of Nancy B. Green ("Estate") as provided in a written settlement agreement by and between all of the devisees of the Estate and Patsy Barnes Hyde, as personal representative of the Estate, among others, effective November 30, 2021. Included in the residue of the Estate was the property located at 212 Lees Cove, Helena, Alabama 35080, which was conveyed to the Trustee by the personal representative by executor's deed executed January 31, 2022, and recorded on the same date in the Probate Court of Shelby County, Alabama, as instrument number 20220131000041950.
8. The Trustee holds title, in trust, to all assets devised to the Trust by the Last Will and Testament of Nancy B. Green.
9. Title to Trust property may be taken in the name of "Patsy B. Hyde, as trustee of the trust for the benefit of Susan Patrice Green under the last will and testament of Nancy B. Green, deceased."
10. The tax identification number of the Trust is [REDACTED].
11. The Trust has not been revoked, modified, or amended in any manner that would cause the representations and statements above to be incorrect.

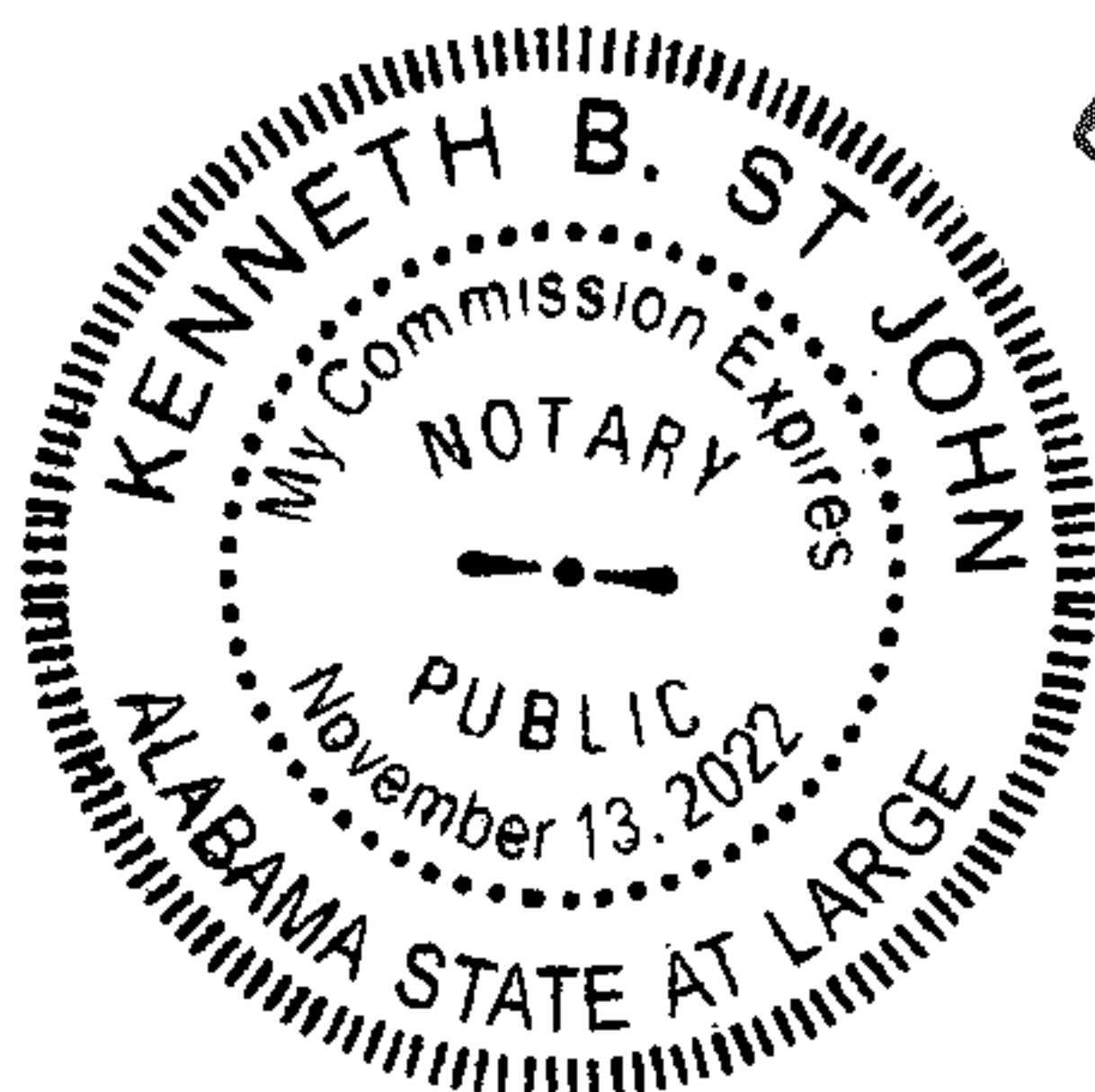
