(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:


**\$958,230.00** of the proceeds come from a mortgage recorded simultaneously herewith.



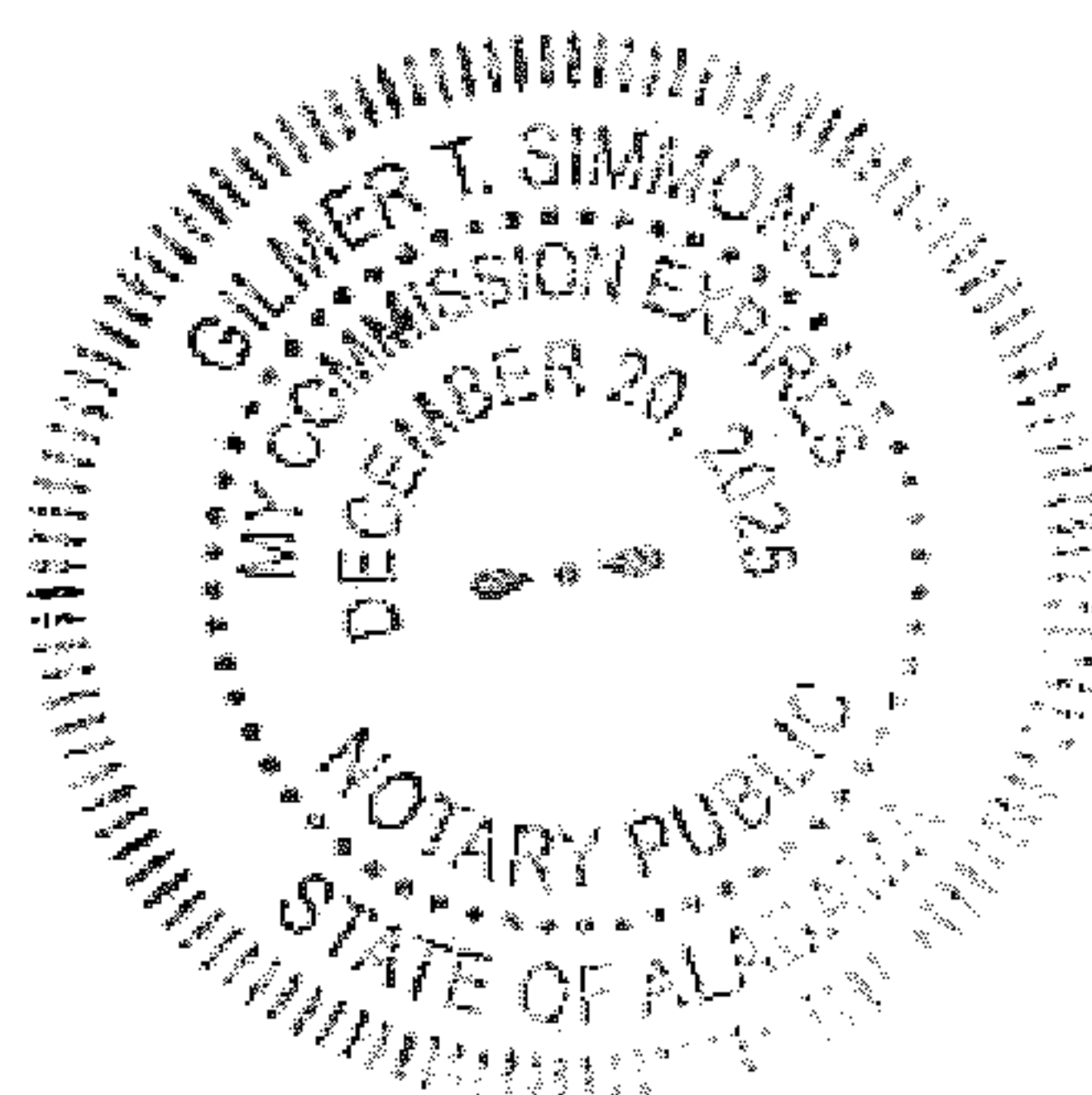
