KNOW ALL MEN BY THESE PRESENTS,, That in consideration of FIVE HUNDRED THIRTY TWO THOUSAND TWO HUNDRED SEVENTY FIVE AND 00/100 D O L L A R S (\$532,275.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Clayton Properties Group, Inc., a TN corporation (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Laura Leal, an unmarried woman (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:

Lot 119, according to the Survey of Final Plat of Simms Landing, Phase 1B, as recorded in Map Book 53, Page 37, A & B, in the Probate Office of Shelby County, Alabama.


Note: \$372,592.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

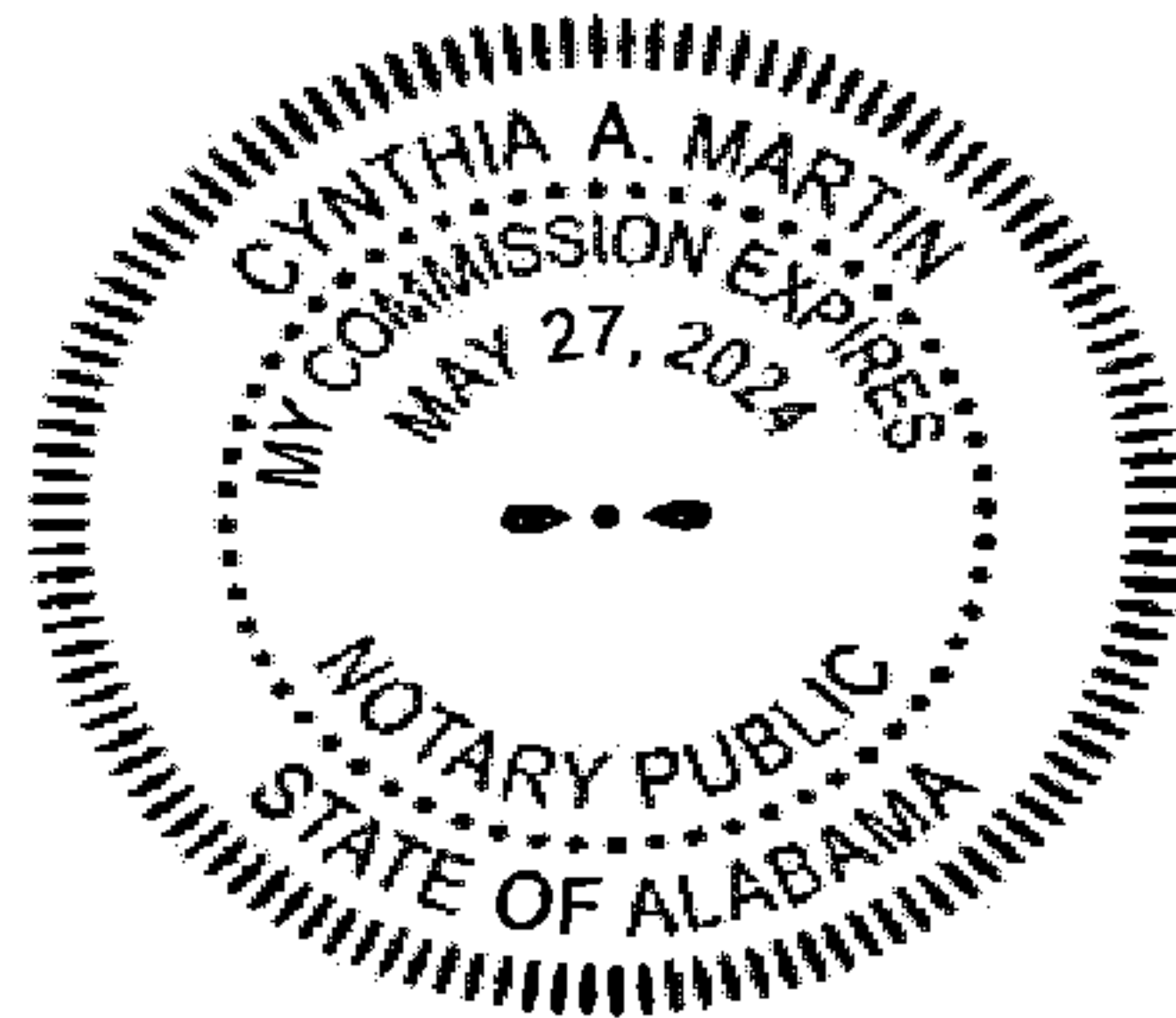


