## POWER OF ATTORNEY

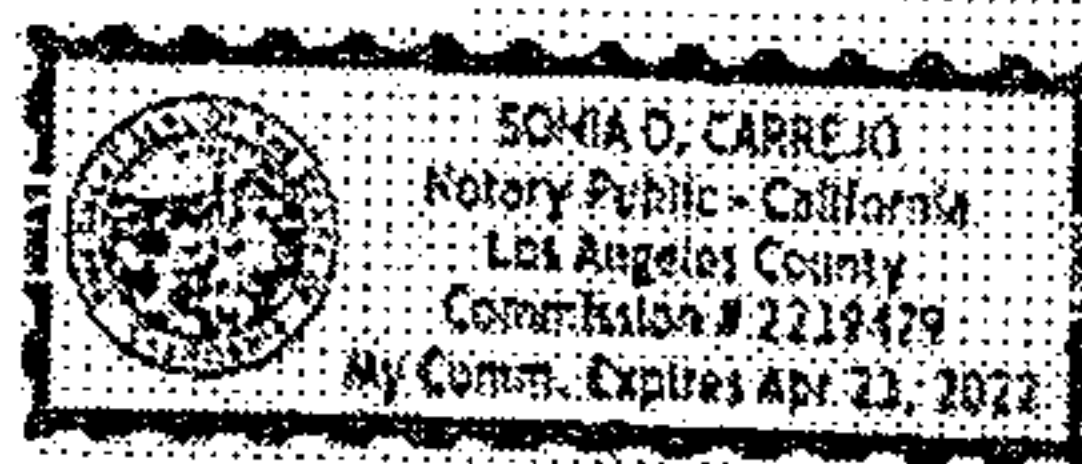

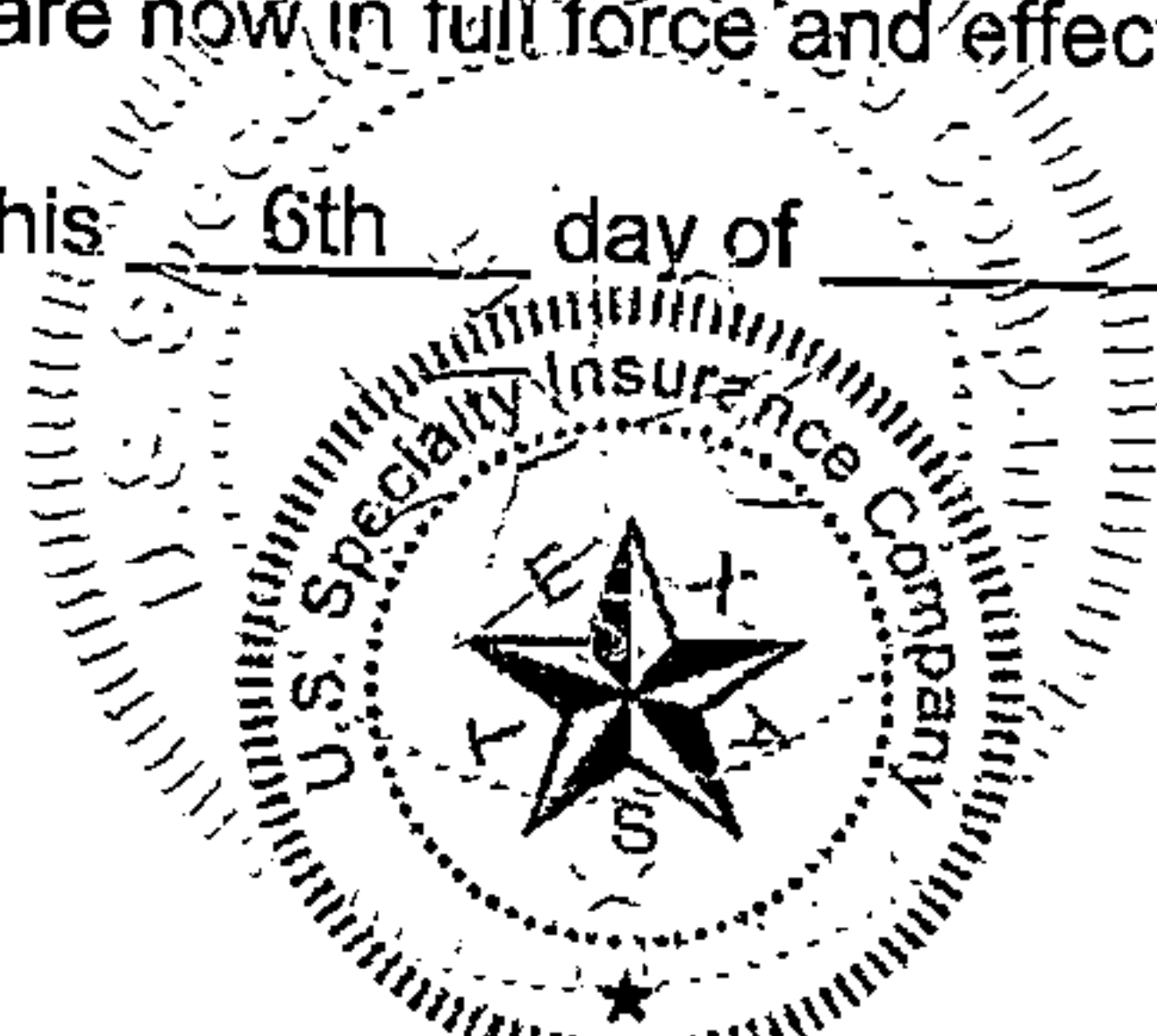
