MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, March 15, 2021, **Lisa Marie Dempsey, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., as mortgagee, as nominee for Guild Mortgage Company LLC, its successors and assigns**, which said mortgage is recorded in Instrument No. 20210316000130970, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **Guild Mortgage Company LLC**, as transferee, said transfer is recorded in Instrument 20220415000156270, aforesaid records, and Guild Mortgage Company LLC, is now the holder and owner of said mortgage and debt; and

WHEREAS, on June 29, 2022, the day on which the foreclosure sale was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted and Guild Mortgage Company LLC did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse; and



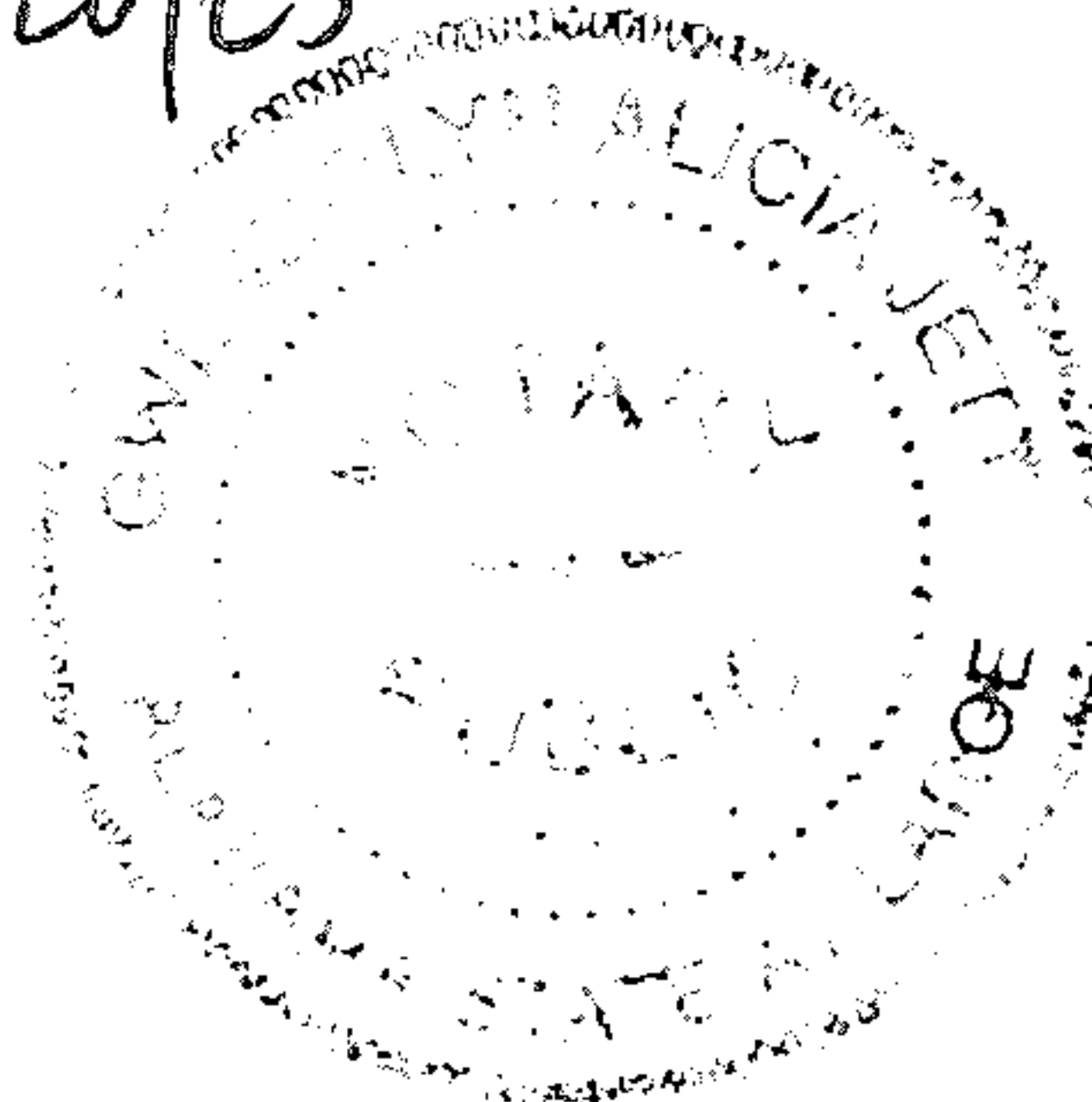
