

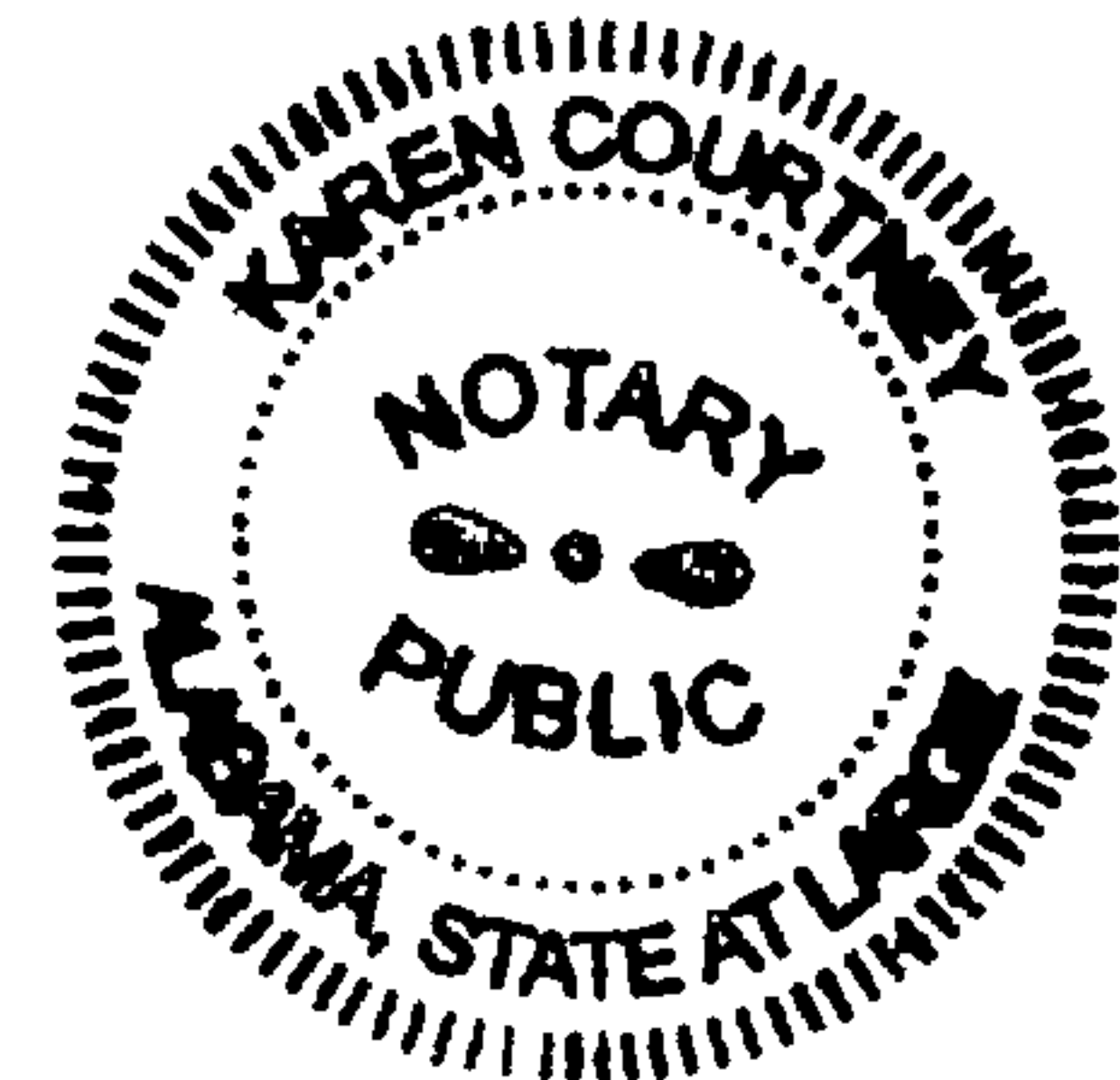

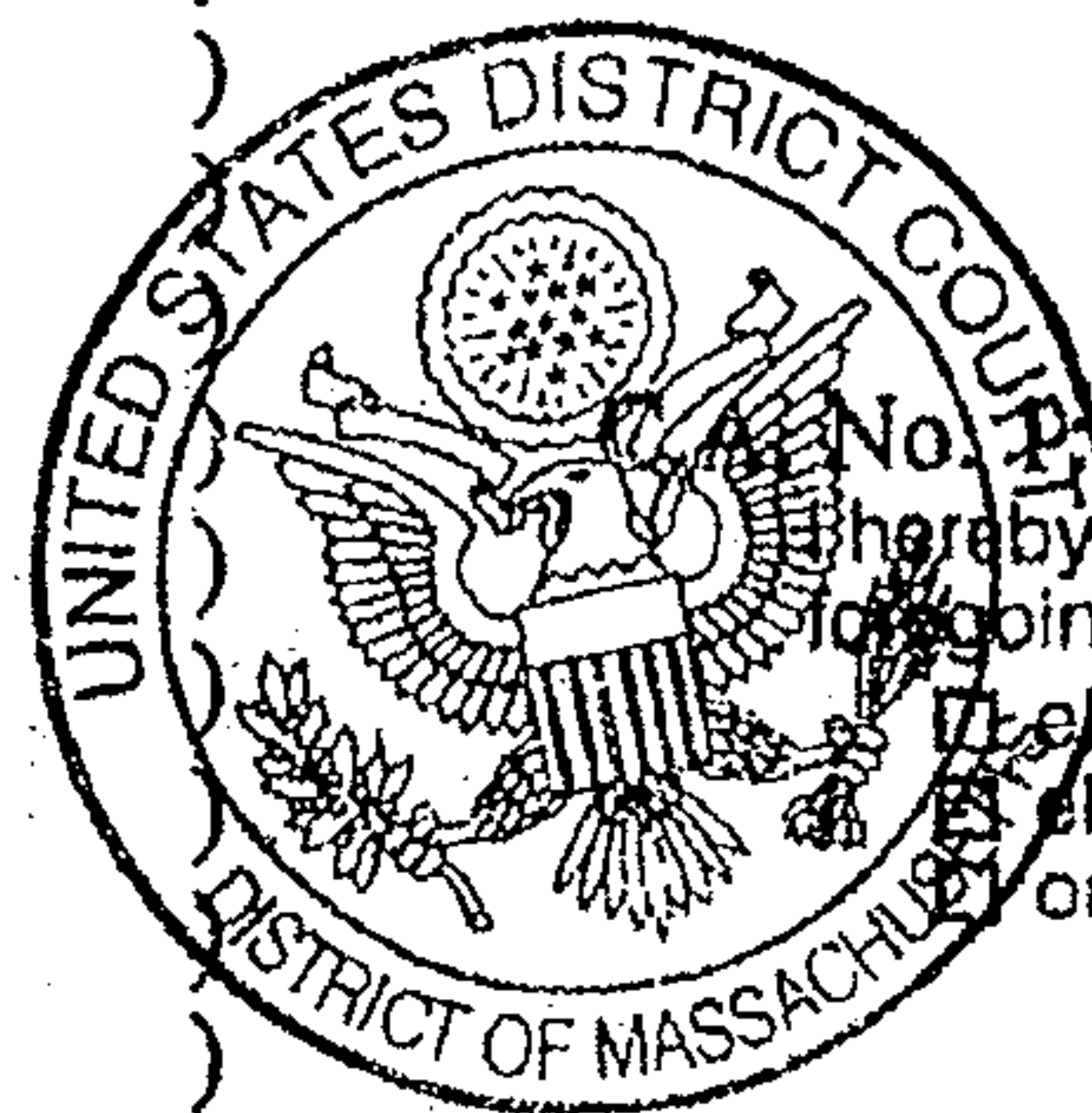

Warnock, Jr. [Docket No. 19]; Defendants Corax International, LLC and Warnock & Associates, LLC having been duly served and failed to plead or otherwise respond to the Complaint as provided for in the Federal Rules of Civil Procedure; and Defendants Corax International, LLC, Warnock & Associates, LLC, and Rudolph M. 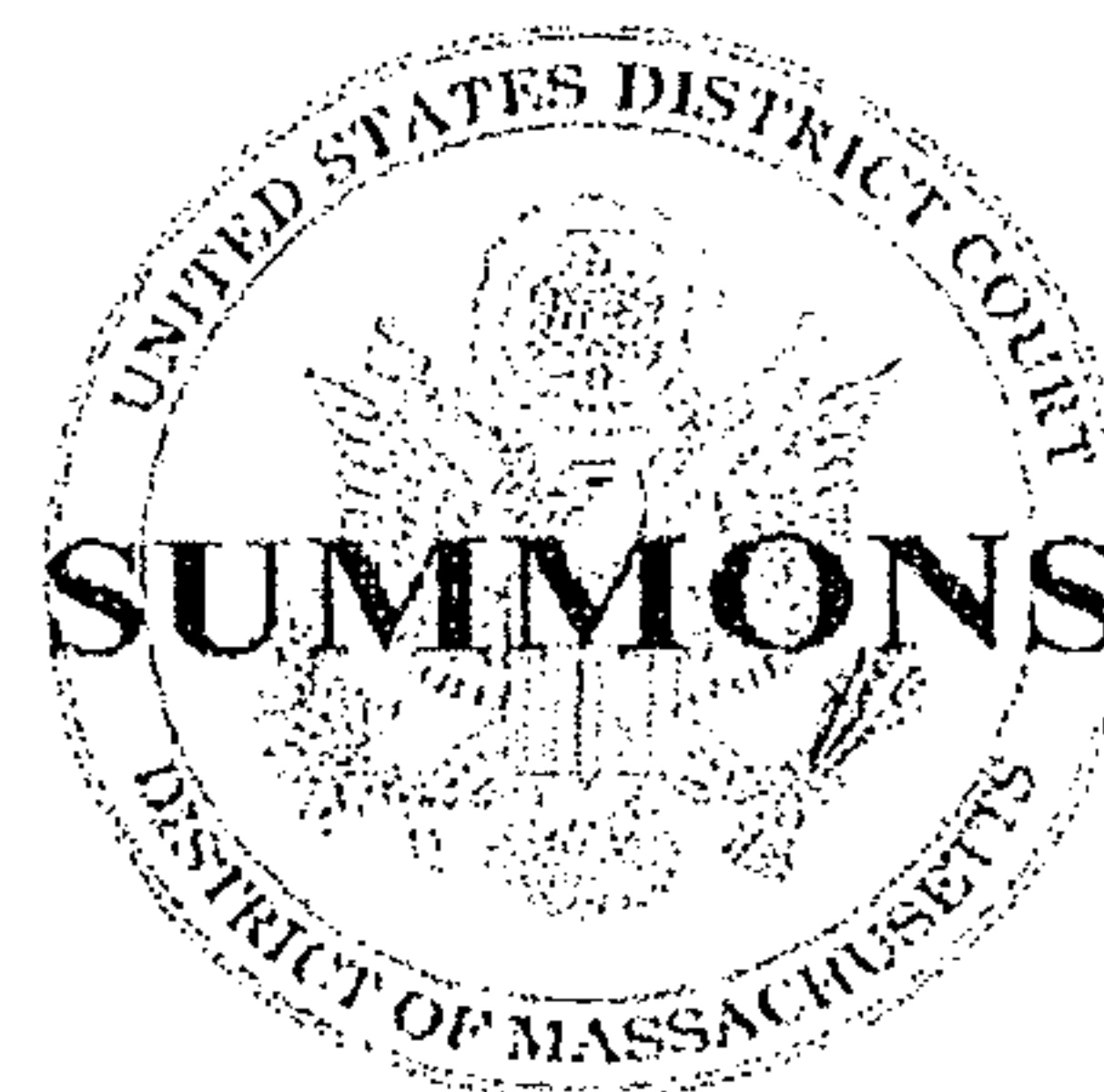

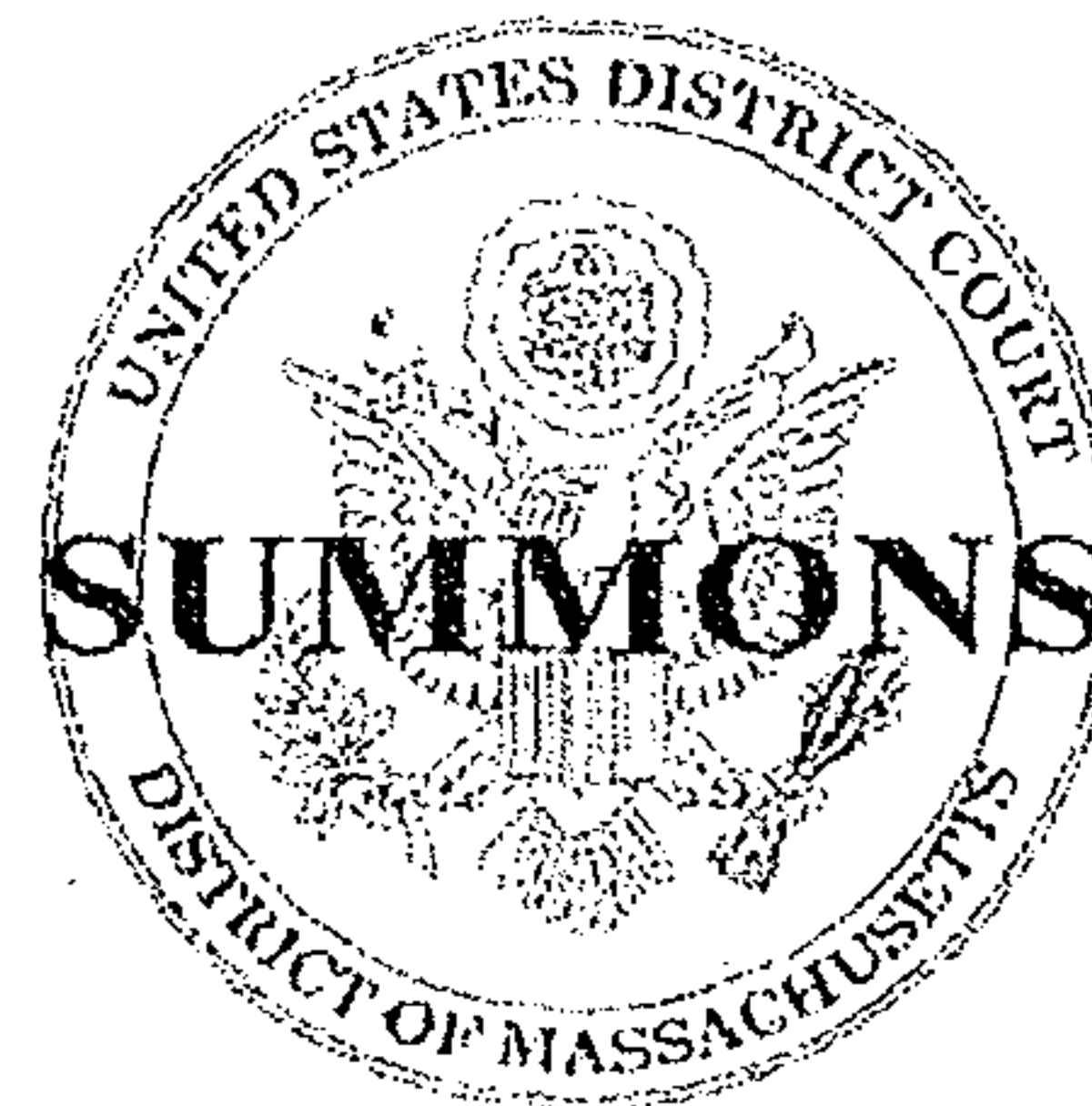

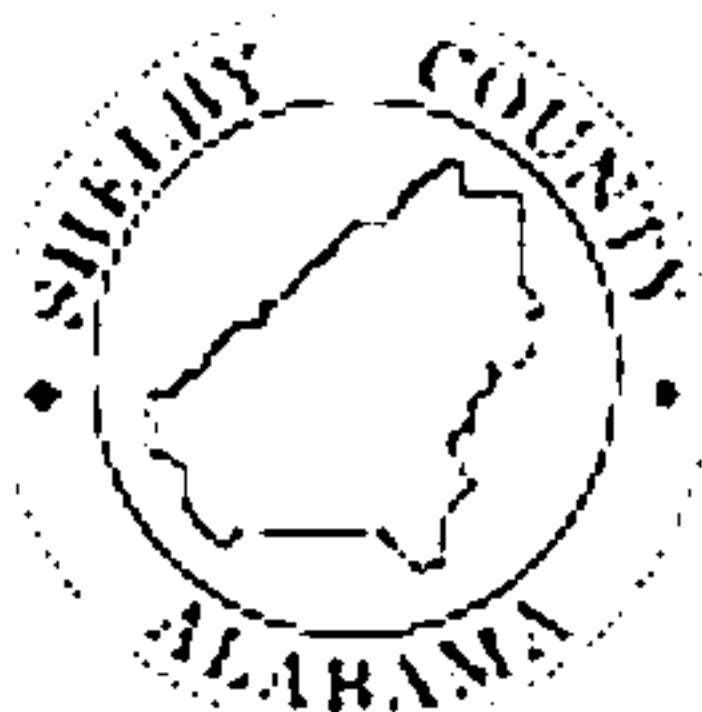
