## CORPORATION WARRANTY DEED

**KNOW ALL MEN BY THESE PRESENTS**, That for and in consideration of FOUR HUNDRED SIXTY SEVEN THOUSAND TWENTY THREE AND 00/100 Dollars (\$467,023.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged Clayton Properties Group, Inc., a Tennessee Corporation (herein referred to as GRANTOR, whether one or more), does by these presents grant, bargain, sell, and convey unto Carl C. Holt, Jr and Barbara S. Edmonds, both unmarried (herein referred to as GRANTEE, whether one or more), as tenants in common with equal ownership of the property and "Surviving Grantee" to hold and retain "First Grantee's" interest during his/her natural life full possession, benefit, and use of this property for that term. At such time as Surviving Grantee's natural life ends, the portion of property conveyed as a life estate from the First Grantee shall revert to the First Grantee's heirs, personal representatives, successors, and assigns. (herein referred to as "Remainderman") and Surviving Grantee's portion of the property to his/her heirs, personal representatives, successors, and assigns.

Conveying the following described real estate situated in Shelby County, Alabama to-wit:


Note: \$317,023.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEE, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEE, their heirs, executors and assigns forever, against the lawful claims of all persons.

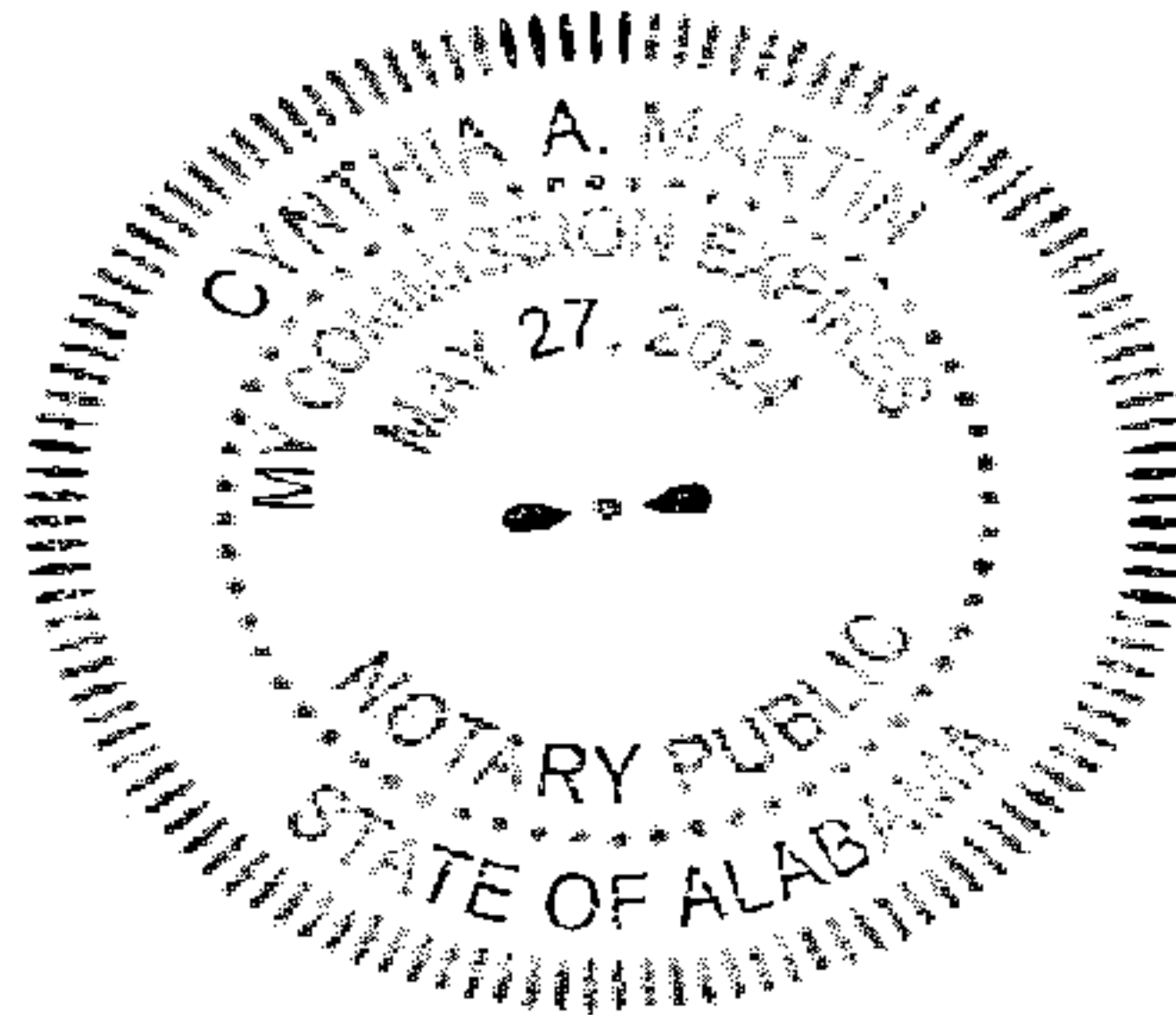



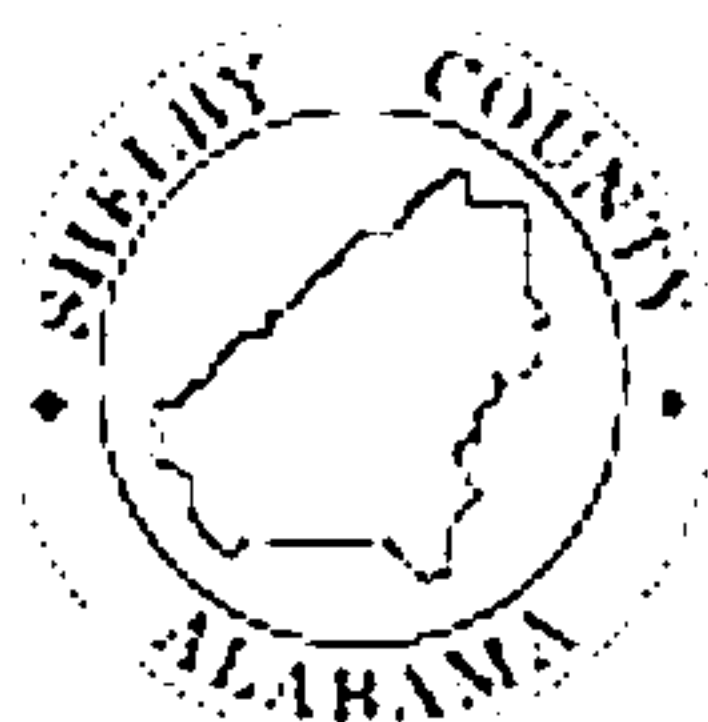
