
Publication of the pendency of this action was made in The Shelby County Reporter, a news paper of general circulation in Shelby, County of Alabama, on 12/11/2019, 12/18/2019, 12/25/2019, 01/01/2020, and on 01/01/2020, called upon the defendants to plead, answer or otherwise defend on or before 01/31/2020, which is thirty days from the date of the last publication of 01/01/2020. More than sixty days has elapsed from the date of the first publication of said notice and the filing of a certified copy therefor in the office of the Judge of Probate of Shelby County.


The guardian *ad litem* has filed an answer and denial and actively participated in the taking of testimony in this action and the court finding that the complaint filed in this action complies in all respects with the requirements of Ala Code §§6-6-560 and -561, it is of the opinion of the court that the plaintiff is entitled to the *in rem* relief prayed for in the complaint.

No defendants have answered this complaint other than the Guardian Ad Litem who denies the complaint but admits that he could not find any entity claiming an interest in the Subject Property other than the Defendants named and set out in this case by the Plaintiff.
