Know All Men by These Presents: That in consideration of **Five Hundred Ninety-One Thousand One Hundred Forty-One and 45/100 Dollars (\$591,141.45)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **EFREM S. MILLER, SR. and BRIDGET R. MILLER** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 518, according to the Final Plat of Grey Oaks Subdivision, Sector 5, as recorded in Map Book 55, Page 3, in the Probate Office of Shelby County, Alabama.

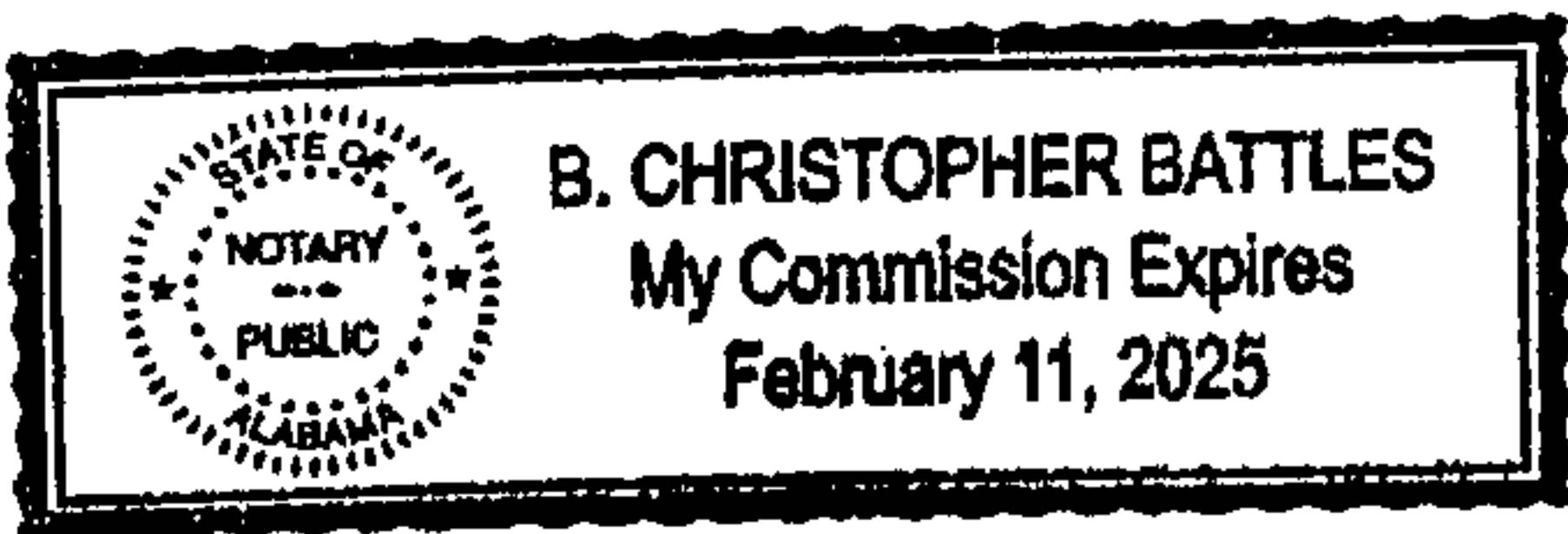

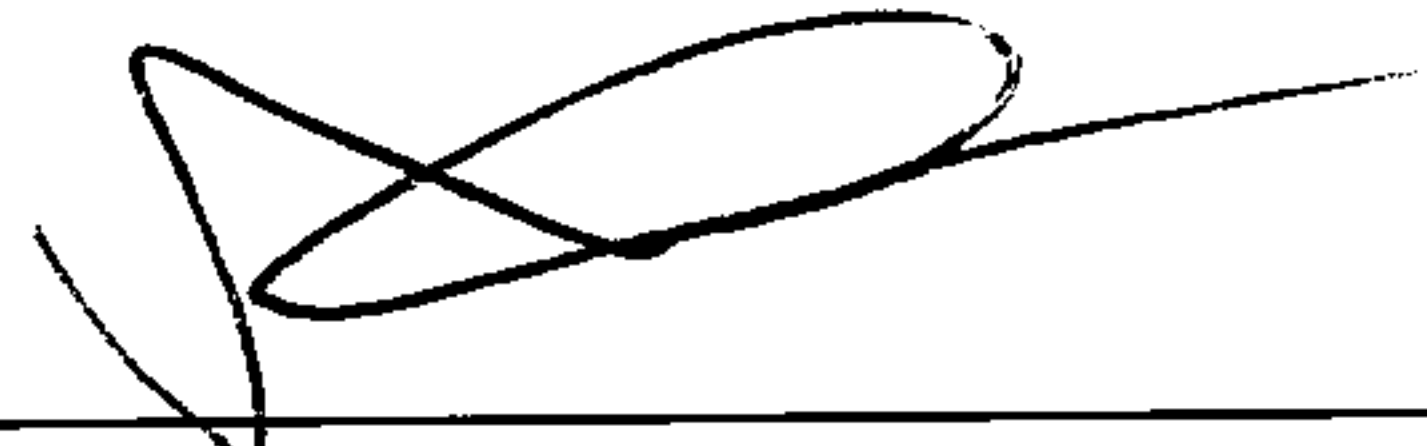

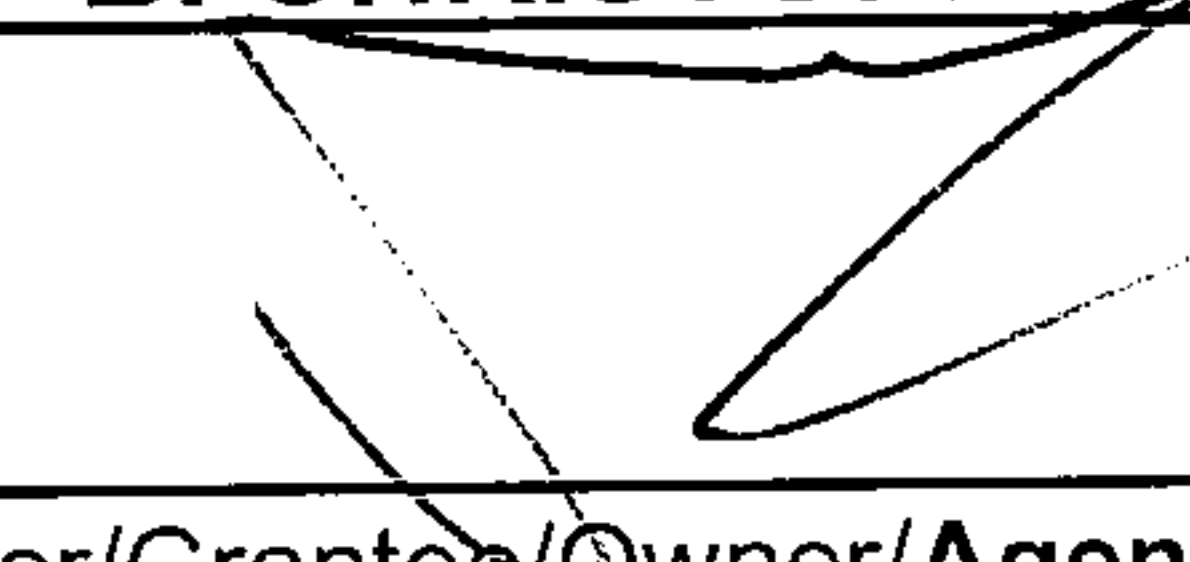
